

SOIL CONSERVATION NEWS

What is a watershed? What does the small watershed act (P.L. 566) mean to Chowan County people? How can people on a watershed apply for assistance in solving their major problems? How much will it cost?

These and many other questions will be answered at a public meeting to be held Friday night, September 12, at the Court House in Edenton. The public is invited to attend this meeting.

Mr. S. L. Daughtridge, area conservationist, SCS will conduct the meeting and answer questions concerning the small watershed act.

Under the small watershed act (P.L. 566), landowners must want the improvements. That means that they must organize together to do a special job. It might be to construct a channel or canal on the major stream in their community. For example, the landowners in the Pollock Swamp watershed might organize for the purpose of doing the necessary drainage work improvement needed. This improvement work might be the main stream and any other ditches in the watershed where two or more persons share the benefits.

After the watershed is organized the group then makes application for Federal funds to assist them in doing the project. An agreement is entered into between the group and the Federal government. This agreement states what each party (local people and government) will provide. An example is the Folly Ditch Drainage District in Gates County. This group was offered 66 1/2 percent on the total cost by the Federal Government leaving 33 1/2 percent for the local people. The Gates County project was entirely drainage (7.4 miles of new channel). Federal funds on this project will be used for clearing the right-of-way and for digging the new channel at the rate of 2/3 the cost, local people providing 1/3 of the cost. P.L. 566 is not a Federal project with local assistance but a local project with Federal assistance. Local people must act on their own to get assistance under the small watershed program.

The purpose of this meeting is to give the facts to the people and let them take their own action. Chowan County supervisors of the Albemarle Soil Conservation District will assist the local groups and so will the agricultural workers in the county

but action must come from the people in the watershed. By the way, a watershed includes all the area draining into a stream—not just the people bordering the stream.

Come out Friday night if you are interested in getting the major streams of the county dug out if your community has a major problem to be solved.

C. W. Overman, County Agent, and myself have planned a tour of several farms in the county on Friday, September 12. This tour will start in Gliden community at 8 A. M., and end at Edenton about 5 P. M. Included on the tour are woodland demonstrations, variety tests, special crops such as Bahia grass, Crotalaria, Coastal Bermuda grass, chemical weed control, disease problems, and drainage systems. A schedule will be mailed to most of the farmers in the county. Visit with us Friday and attend the small watershed meeting Friday night.

Questions - Answers About N. C.

Q. How did North Carolina's Sapphire Country get its name?

A. It is so called because of the gemstones found in the area, and because of blue sky and blue water.

Q. What is the largest Indian Reservation east of the Mississippi?

A. The Qualla Boundary, in the Great Smoky Mountains of North Carolina. It covers 50,000 acres and is the home of the Eastern Band of the Cherokee Indians.

Q. What is the value of the travel industry to North Carolina?

A. Over \$300,000,000 a year, by Federal Reserve Bank estimates.

Q. How many people visit North Carolina's Variety Vacationland each year?

A. Over 10,000,000 — many spending extended vacations in the mountain, coast and mid-State resorts, and many others stopping briefly enroute north or south.

Q. Is it necessary for me to obtain a permit for camping in the Great Smoky Mountains National Park?

A. No permit is necessary if you stop at one of the developed campgrounds (in the North Carolina section of the Park they are Deep Creek, Smokemount and Balsam Mountain). A permit is required for camping in other sections of the Park.
