Fluid Milk Sales Increase In State

For the first months of 1959, fluid milk sales exceeded the same period of 1958 in North Carolina. Increases ranged from a low of 1.9% in May to a high of 8.4% in January, for an average increase for the five month period of 6% over 1958. From September, 1958, through May, 1959, sales exceeded the previous year for all months.

Prices paid to producers for the first five months of 1959 averages \$6.00 per cwt. for milk containing 3.91% butterfat as compared with the 1958 average for the same period of \$6.05 per cwt. with a butterfat test of 3.96%. On a 4% butterfat basis, the average for the first five months in 1959 was \$6.05 per cwt. as compared to \$6.07 in 1958.
