BLOOMING PROBLEM
Did your dogwoods fail to bloom last spring? The reason may have been a lack of sunlight or excessively rapid growth. N. C. State University specialists suggest giving the plants more light, if that is a problem. If the trees are growing too fast, use a fertilizer with no nitrogen. A word of caution: don't expect too many blossoms from young plants, especially when they are growing fast. Plants in poor soil, making slow growth will usually bloom earlier.
