All persons owning land, or any interest in land, within the boundaries of Chowan County Drainage District Number Three (Bear Swamp Watershed) are hereby notified that the Board of Commissioners of said Drainage District propose to issue bonds, or assessment anticipation note (s) of the said Drainage District for the purpose of providing money for the payment of the total cost of the improvement and organizing the Drainage District.
