

CHOWAN COUNTY DISTRICT COURT

MAY 4 SESSION:

Raymark Devon Bembury, guilty, driving while license revoked, sentenced to 30 days suspended with 12 months' unsupervised probation, fined \$250 plus court costs, ordered not to operate a motor vehicle until relicensed by DMV, pay \$100 today and balance in 20 days.

Voluntary dismissal was granted in the case of Melvin Bonner, charged with permitting operation of a motor vehicle with no insurance.

Sharon Myrick Bonner, guilty, sentenced to 20 days suspended with 12 months' unsupervised probation, fined \$150 plus court costs. Voluntary dismissal was granted on a charge of possessing open container after consuming alcoholic beverage.

Darrell Lavone Boyce, guilty, resisting arrest, sentenced to 60 days suspended with 12 months' supervised probation, fined \$200 plus court costs, ordered to obey curfew to be determined at discretion of probation officer. Credit given for one day spent in jail awaiting trial.

Heather Byrum Cahoon, guilty, unsafe movement, fined \$150 plus court costs, and \$100 attorney's fee. Ordered to pay all sums due by June 3.

Voluntary dismissal was granted in the case of Dennis S. Carswell, charged with failure to avoid speed to avoid an accident.

Bishari Coleman, guilty, speeding 70 in a 55 mph zone, prayer for judgment granted upon payment of court costs by May 24.

Voluntary dismissal was granted in the case of Mauricio Cruz, charged with inspection violation and having no operator's license.

Voluntary dismissal was granted in the case of Tobie Ann Davenport, charged with an inspection violation.

Jamie Michele Drager, guilty, speeding 70 in a 55 mph zone, fined \$10 plus court costs.

Roland Gagne, Jr., guilty, speeding 70 in a 55 mph zone, fined \$25 plus court costs.

Russell Walter Hahnel, guilty, driving while impaired, sentenced to 30 days suspended with 12 months' supervised probation, fined \$100 plus court costs, ordered to commit no criminal offense, obtain substance abuse assessment, surrender driver's license, not operate a motor vehicle until relicensed by DMV, submit to testing, not have any alcohol upon person or breath while on probation. Appealed. Voluntary dismissal was granted on charges of having no operator's license, speeding 78 in a 55 mph zone, and providing false information to a law enforcement officer.

Samuel Andrew Hall, guilty, exceeding safe speed, fined \$10 plus court costs.

George Merlyn, guilty, speeding 64 in a 55 mph zone, prayer for judgement continued upon payment of court costs.

Christopher J. Jackson, guilty, driving left of center, and hit and run, sentenced to 20 days suspended with 12 months' unsupervised probation, fined \$150 plus court costs.

Leslie Moore Jordan, guilty, no operator's license and providing false information to a law enforcement officer, sentenced to 20 days suspended with 12 months' unsupervised probation, fined \$150 plus court costs. Weapon to be destroyed and all sums due to be paid by May 5. Voluntary dismissal was granted on a charge of carrying a concealed weapon.

Ernest Lee Lane, guilty, driving while impaired, sentenced to six months suspended with 18 months' unsupervised probation, fined \$400 plus court costs, ordered to commit no criminal offense, obtain substance abuse assessment, not operate a motor vehicle for 60 days, not have any alcohol on breath or person. Voluntary dismissal was granted on charges of driving while license revoked and speeding 80 in a 55 mph zone.

Jack Marcus Lane, guilty, reckless driving, sentenced to 30 days suspended with 12 months' unsupervised probation, fined \$400 plus court costs. Ordered to pay all sums due by June 3. Voluntary dismissal was granted on a motorcycle/

moped helmet violation.

Jessica Ann Lane, guilty, allowing an unlicensed person to drive, sentenced to 20 days suspended with 12 months' unsupervised probation, fined \$100 plus court costs. Voluntary dismissal was granted on a charge of aiding and abetting impaired driving.

Voluntary dismissal was granted in the case of Christian C. Leary, charged with possession of a fictitious or revoked driver's license and providing false information to a law enforcement officer.

Voluntary dismissal was granted in the case of Josephine S. Leary, charged with a window tinting violation.

Voluntary dismissal was granted in the case of Adrian Annette Lewis, charged with speeding in a school zone.

Justin J. Mayberry, guilty, speeding 80 in a 55 mph zone, fined \$100 plus court costs.

Thomas More O'Hare, guilty, improper equipment, assessed court costs.

Sheila Moore Overton, guilty, improper equipment, assessed court costs.

John Wilmer Parker, guilty,

speeding in a school zone, prayer for judgment continued granted upon payment of court costs.

Michael E. Privott, guilty, worthless check, sentenced to 30 days suspended with 12 months' unsupervised probation, and ordered to pay \$370 restitution. Appealed.

Voluntary dismissal was granted in the case of Timothy A. Privott, charged with allowing the use of an unregistered vehicle, permitting operation of vehicle without insurance, having open container after consuming alcoholic beverage, and having unsealed alcoholic beverage in vehicle.

Antonio Lamont Rome, guilty, possession of marijuana and resisting arrest, sentenced to 30 days suspended with 12 months' unsupervised probation, fined \$150 plus court costs, ordered not to use, possess or control any illegal drugs or controlled substance. Confiscated controlled substance to be destroyed, all confiscated funds to be released to Edenton-Chowan Schools.

James Clayton Rouson, guilty, driving while license

revoked, sentenced to 30 days suspended with 12 months' unsupervised probation, fined \$250 plus court costs, and ordered not to operate motor vehicle until licensed by DMV.

Probable cause was found in the case of William Satterfield, charged with robbery with a dangerous weapon. The case was transferred to Superior Court.

Voluntary dismissal was granted in the case of William Holt Shaw, Jr., charged with an unsafe movement.

Ralph Spears, guilty, misdemeanor probation violation, probation revoked and active 45-day sentence imposed.

Phillip Ross Taylor, guilty, reckless driving, sentenced to 30 days suspended with 12 months' unsupervised probation, fined \$250 plus court costs. Voluntary dismissal was granted on a charge of having no operator's license.

Willie Athens Twine, guilty, driving while license revoked, sentenced to 45 days suspended with 12 months' supervised probation, fined \$300 plus court costs, ordered not to operate a motor vehicle until relicensed

by DMV, and serve active 14-day sentence at direction of probation officer. Voluntary dismissal was granted on a charge of driving while impaired.

Christie A. Vianale, guilty, speeding 70 in a 55 mph zone, fined \$25 plus court costs.

Bobby Eugene White, guilty, reckless driving, sentenced to 30 days suspended with 12 months' unsupervised probation, fined \$300 plus court costs, ordered to pay \$300 today and balance due by May 24.

Darnell White pleaded not guilty, but was found guilty, of driving while impaired, sentenced to 30 days suspended with 12 months' unsupervised probation, fined \$50 plus court

costs, \$175 attorney's fee, and commit no criminal offense in any jurisdiction while on probation.

Roy Edward Wilson, guilty, driving while impaired, sentenced to 24 months' suspended with 24 months' supervised probation, ordered to serve four-month active sentence, pay \$300 fine plus court costs, obtain substance abuse assessment, surrender driver's license for one year, not use or possess any illegal drug, submit to testing, not have any alcohol upon person or breath. Appealed. Voluntary dismissal was granted on charges of driving left of center and having open container after consuming alcoholic beverage.
