

# CHOWAN COUNTY DISTRICT COURT

## NOVEMBER 9 SESSION:

Ivey Lee Basnight pleaded not guilty, but was found guilty, of driving while impaired. Basnight was sentenced to 120 days suspended with 12 months' supervised probation, fined \$300 plus court costs, \$175 attorney's fee, ordered to obtain substance abuse assessment, surrender license, complete 72 hours of community service within 90 days and pay fee. Basnight elected to serve 120 days active to run concurrently with other sentence.

Basnight pleaded not guilty, but was found guilty, of assault with a deadly weapon and was sentenced to active term of 120 days.

Voluntary dismissal was granted in the case of Mary Bivens, charged with two counts of illegally obtaining property.

Voluntary dismissal was granted in the case of Lessel Jackson Bond, charged with assault on a female.

Jasper L. Cofield, guilty, resisting arrest, sentenced to 45 days suspended with 12 months' unsupervised probation, ordered to pay court costs, not assault or threaten William or Mary Cofield, complete 24 hours of community service within 60 days and pay fee, pay all sums due by Nov. 9. Voluntary dismissal was granted on a charge of

second degree trespass.

Deon C. Copeland, guilty, assault on a female and first degree trespass, sentenced to 75 day active sentence, given credit for 14 days spent in jail while awaiting trial. Copeland also pleaded guilty to attempted misdemeanor breaking and entering, an additional count of first degree trespass, and resisting arrest. He was sentenced to an active 45 day term to run at expiration of previous sentence. Credit was given for 14 days spent in jail awaiting trial. Voluntary dismissal was granted on a related charge of resisting arrest.

Anton Lamont Flemming, guilty, resisting arrest, sentenced to 30 days suspended with 12 months' unsupervised probation, ordered to pay court costs, not violate any laws, complete 24 hours of community service within 60 days, and pay fee.

Steven Dail Forehand, guilty, possession of marijuana and possession of drug paraphernalia, sentenced to 45 days suspended with 23 months' intensive supervised probation, ordered to pay court costs, complete active 5 day term, attend not less than one AA meeting every week and complete treatment program with Albemarle Mental Health.

Alonzo Ramone Hall, guilty, im-

proper loading/covering vehicle, assessed court costs; leaving scene of accident with property damage, prayer for judgment continued granted upon completion of 30 hours of community service with Sheriff's Dept. Reparation Program.

Voluntary dismissal was granted in the case of Troy Holley, charged with simple assault.

Stacey L. Holley, guilty, disorderly conduct, sentenced to 30 days suspended with 12 months' unsupervised probation, ordered to pay court costs, not violate any laws, complete 10 hours of community service within 30 days and pay fee, pay all sums due by Nov. 19. Voluntary dismissal was granted on a charge of resisting arrest.

Bruce Levine Jordan, guilty, speeding 64 in a 55 mph zone, fined \$10 plus court costs, ordered to pay by Nov. 12.

Walter Allen Norman waived a probable cause hearing on multiple counts of breaking and entering, larceny, possession of stolen goods, and attempted breaking and entering, and the case was transferred to Superior Court.

Steven Edward Nuckles, guilty, driving while impaired, sentenced to 60 days suspended with 12 months' supervised probation, fined \$100 plus court costs, ordered

to obtain substance abuse assessment, not operate a motor vehicle for one year, complete 48 hours of community service within 90 days, and pay fee; Nuckles may transfer to unsupervised probation upon payment of all court indebtedness, completion of assessment and/or treatment from Albemarle Mental Health. Voluntary dismissal was granted on a charge of having no operator's license.

Raymond Carl Phillips, guilty, reckless driving and resisting arrest, sentenced to 45 days suspended with 12 months' supervised probation, fined \$500 plus court costs, ordered not to operate motor vehicle until relicensed by DMV, obtain substance abuse assessment, complete 24 hours of community service within 60 days, and pay fee. Voluntary dismissal was granted on charges of driving while impaired and failure to burn headlights while operating a motorcycle.

Voluntary dismissal was granted in the case of Dianna F.

Privott, charged with simple assault.

Reuben Michael Rascoe, guilty, gambling, sentenced to 30 days suspended with 12 months' unsupervised probation, fined \$100 plus court costs, ordered not to violate any laws including gambling, not go upon premises of 200 block of East Carteret; the court ordered that the \$20 confiscated be turned over to the Edenton-Chowan Schools. Rascoe was ordered to pay \$120 today and balance by Nov. 19.

Ricky Dwight Sexton, guilty, improper equipment, assessed court costs.

Elizabeth C. Tetterton, guilty, speeding 54 in a 45 mph zone, fined \$10 plus court costs.

George Edmund Towner, guilty, failure to wear seat belt and having no child restraint system, fined \$25. Voluntary dismissal was granted on charges of using expired registration and having no operator's license.

Charlie W. White, Jr., guilty, possession of drug paraphernalia and possession of marijuana,

prayer for judgment continued granted upon payment of court costs in each case and completion of 24 hours of community service in each case.

Shandell L. Williams, guilty, possession of marijuana, sentenced to 10 days suspended with 12 months' unsupervised probation, fined \$100 plus court costs, ordered not to violate any laws, not use, possess or be in control of any illegal drugs, pay \$27 today and balance due by Nov. 19.

James Wilson, guilty, simple assault, sentenced to 45 days suspended with 12 months' supervised probation, assessed court costs, ordered to report to Albemarle Mental Health for anger management assessment, complete 100 hours of community service within 60 days, and pay fee. Wilson also pleaded guilty to assault with a deadly weapon and was granted a prayer for judgment continued upon payment of court costs. Voluntary dismissal was granted on a charge of communicating threats.

## Petty Officer aboard American destroyer

Navy Petty Officer 1st Class Douglas E. Cole, whose wife, Donna, is the daughter of Lynwood and Bobbie Barwick of Edenton, recently participated in the Chilean Phase of UNITAS while on a five-month South American deployment aboard the destroyer USS O'Bannon, homeported in Mayport, FL.

During this phase, Cole's ship participated in freeplay and unscripted at-sea warfare exercises with the U.S. and Chilean Navies including three separate

at-sea phases, which concentrated on subsurface air and surface warfare training. This phase also took them through the Straits of Magellan.

Latin for "unity," UNITAS is an annual deployment that cir-

cumnavigates South America, and has been a key element in promoting interoperability and friendship between U.S. and Latin American navies since 1960.

Destroyers, like Cole's ship, have traditionally been the workhorses of the U.S. Navy, defending battle groups against attack.

A 1988 graduate of Vinita High School in Vinita, OK, Cole joined the Navy in October, 1988. He is a 1998 graduate of Florida Community College, Jacksonville, FL, with an associate degree.


