

CONGRESS FAILS TO KILL THE DEATH TAX

Recently Congress rejected a measure that would have permanently repealed the estate tax. The reality is that high estate taxes still exist. Waiting around for Congress to change the law could cause you to lose a large chunk of your estate to taxes.

As you probably know, the 2001 Tax Act included major estate tax changes. From 2002 through 2009, the top estate tax rate gradually decreases, and the amount exempt from tax gradually increases. Then in 2010, the estate tax disappears - but only for one year. In 2011 the estate tax is due to return to the 2001 rules unless Congress changes the law. The uncertainty of permanent estate tax repeal coupled with the changes planned for the next eight years makes estate planning more important than ever.

Where do you start? Begin by making sure your plan documents utilize basic tax-cutting strategies. Outdated language in your will or other planning documents may prevent your estate from taking advantage of the changing rates and exemptions. If you own substantial assets, review your gifting program for ways to transfer your wealth tax-free. For example, in 2002 you can give away \$11,000 per recipient to as many people as you want. If you're a business owner, planning is essential to ensure that your business will pass to your heirs as

Make sure guardians are named for young children and that your will, durable power of attorney, and medical directives are up to date.
