Half of the fundraising goal is needed to secure a letter of credit, a requirement of the league. That comes first to ensure the 14-team CPL that the Steamers are fiscally able to endure a full season next summer and before next year's schedules are determined.

Plans include using the remaining \$25,000 to hire a general manager who can devote fulltime employment to focusing on sales and marketing. The Steamers are the league's only team without a GM.

Truck slams into car, kills woman

Virginia woman was killed Friday afternoon after the car she was riding crossed into the path of pickup truck just north of the South Bridge in Chowan County, according to the N.C. Highway Patrol.

Linda Miller Chapman, 65, of Norfolk, Va. became Chowan County's first fatality of 2010 when a truck slammed into a car she was riding, said the Highway Patrol on Monday. No additional information about the three other victims was available at the Patrol's district office in Elizabeth City.

Sgt. E. J. Forbes declined to reveal the identity of the deceased woman on Friday, pending notification of next to kin. Neither did he identity the three others involved in the 4:30 p.m. crash that sent them to Chowan Hospital with serious injuries.

Chapman was riding as a front seat passenger the car failed to stop at in a late model Chevrolet Aveo, a compact rental car with Ohio license plates, Forbes said. That car, driven by a female, was traveling northwest on Indian Trail Road when it crossed into the path of a southbound Toyota Tundra pickup, Forbes said.

Forbes said he was not prepared to conclude that the driver of the stop sign, an intersection that also has flashing lights.

"At the very least, she failed to yield the right of way," Forbes said.

The driver of the truck slammed into the passenger side of Chevrolet, crushing the right side of the car.

"Evidence shows that the truck rolled after

impact." Forbes said. Although the truck was traveling toward the Sound Bridge on Haughton Road (N.C. 37), it came to a rest facing northwest across a lane used for southbound merging onto N.C. 32 off Poplar Neck Road. The posted speed limit on that stretch

of road is 55 miles per

Impact of the crash also spun the Chevrolet completely around before coming to a rest off the road. The car was heading northwest toward Edenton at the time of the crash, Forbes said.

Although Friday's crash marked the county's first of the year, Sheriff Dwayne Goodwin said the intersec-

tion, which in addition to a diagonal crossroad has two merging lanes going in opposite directions has a history of deadly wrecks.

"I can think of three right off the top of my head and I'm sure there are more," Goodwin said.

The crash site snarled traffic to a stop in several different directions at the intersection.

Schools tap into reserves

The Edenton-Chowan Board of Education adopted a local budget Monday night totaling just over \$4.3-million for fiscal year 2010-2011.

The budget contains an appropriation from the school system's fiscal reserves totaling \$800,000 \$450,000 to meet current expenditures; expense \$100,000 for capital outlay projects; and \$250,000 in contingency (emergency) funds.


"The use of the fund balance to meet ongoing current expense costs is of particular concern," Superintendent Allan Smith noted in his budget message to the board. "The long-term effects of dependence upon fiscal reserves to meet recurring expenses cannot be sustained.

"However, considering the present financial situation it is recommended that the board of education draw upon the reserves once again for the coming school year.'

Smith added, however, that this practice was one the school system could not continue indefinitely.

Lowe informed commissioners that other coun-


ties use churches as polling stations. Nonetheless, she was asked if she had a backup plan.
