Hotel Hinton parking agreement nears finish

The proposed lease for parking lot spaces that would be made available to the Hotel Hinton will be discussed and ready to be acted upon at the town council's June 9 monthly meeting, town officials said.

In a May 22 memo to the town council, Town Manager Anne-Marie Knighton said that after consultation with town attorney Hood Ellis, the town was "just about ready" for the agreement to be executed.

The proposed lease will be between the town and SAGA - the developer that is planning to restore the
