



To Investigate Pension Frauds. State Auditor Baxter Durham and Treasurer Ben Lacy have been sub-

Treasurer Ben Lacy have been sub-poeped to place before the Sampson county grand jury certified records of the list of pensioners and pension funds paid out for that county. It was learned. The Sampson grand jury is investigating alleged irregularities in the administration of the pension fund, follwing up reports to State Auditor Durham several weeks ago that pen-sion checks for Confederate veteraps dead for three years had been endors-ed.

Following the discovery of evident irregularities in the administration of the fund in that county. Major Dur-ham ordered a checking of the vital

ham ordered a checking of the vital statistics records for the county on file in the state department of health. This work is reported to have reveal-ed the names of a number of deceased veterans whose names had been re-tained on the county list and for whom checks had been regularly insued, these checks later being endorsed and cashed by some person not designated.
