WOMAN IS GIVEN LONG SENTENCE

Maude Nelson Enters Plea of Murder In Second Degree

Maude Nelson, 21 charged with the murder of Mrs. Martha McClure, 35 near Andrews last April 2, Thursday was sentenced to serve from 15 to 20 years in State's Prison, Raleigh, after defense attorneys had entered a plea of guilty of murder in the second degree. After the State and defense had rested, Judge H. Hoyle Sink, presiding over Cherokee county Superior Court here, suggested that a plea of second degree murder be entered, although the evidence, he said, was ample to sustain first degree murder. The court stated that it would not

let a first degree verdict stand, owing to the low mentality of the defendant.

Acting upon the court's suggestion, the defense attorneys entered the plea.

Trial of the case began at 8 o'clock Thursday morning, August 11th and more than two hours were spent in selecting a jury from a special venire of 40 men. A statement, signed by Mrs. McClure on her death bed, was presented in evidence. It was to the effect that on April 2 Maude Nelson asked her to go to the home of her aunt, Mrs. Theo Gibby, to see Mrs. Gibby's sick baby.

On the way, she said, the Nelson heard that she objected to her assowoman told Mrs. McClure she had cating with her daughter. Mrs. McClure, in her statement, said she told her that she did not say this, whereupon the Nelson woman accused her of lying and stabbed her in the left breast with a knife.

Physicians testified that as a result of the wound, pneumonia developed, from which she died April 17.

Maude Nelson testified that Mrs. McClure attacked her first with a rock.

Lawyers for the defense were Harry P. Cooper, of Murphy, and Felix Alley, of Waynesville. Solicitor John M. Queen, of Waynesville, was assisted by Moody and Moody of Murphy.

Ten State's witnesses were examined and two for the defense. The trial ended at 3 o'clock.
