## Men Return to Work NOVEMBER TERM And Better Hours

nesday night wrote the final chapter of the brief strike of approximately 500 employes at the Nantahala dam being built by the Utah Construction Company. Under the agreement, signed by representatives of the company and the Buildings Trades department of the American Federathigher pay and better working conditions

The Washington meeting, held under the supervision of the U.S. Department of Labor, was merely to settle details. A tenative agreement already had been reached by union representatives and Nantahala officials of the Company at conferences held at Andrews with Bryce P. Holcombe, Labor department Commissioner of Conciliation. The men returned to work Tuesday morn-

All the strikers who wished were taken back "without prejudice." Told of the tentative agreement by union readers on Monday afternoon, the men were urge dto go back to work without any ill feeling either toward the Company, or against those who had failed to go out on strike. The Company agreed to seek the release of all who had been arrested in connection with strike activities.

Details of the Washington pact were not disclosed, but it was described by A. F. of L officials as "a master agreement". It is reported to have arranged for a "closed shop". covering carpenters, engineers, electticians and laborers. In addition to more pay, the men will get shorter hours.

A special agreement is reported to have been reached, or will be drawn, at once, regarding "tunnel workers." The exact amount of the wage increase demanded by the men was not made public. The increases finally accepted at the Washington parley, also were not announced. It was definitely stated that the workers will benefit, considerably in both respects.

Demands had been made by the men for better health facilities: it being declared that workers were forced to travel to their homes before being able to change into dry clothing from their often soaking wet working garb. High boots also were demanded for men forced to work in water, or deep mud. Both these requests are said to have been satisfactorily adjusted, in Washington.

Through freight service between Murphy and Asheville was started by the Southern Railway on Monday TVA CREW BUSY resulting in deliveries on the same day of shipment. Heretofore freight ON CLEARANCE, laid over in Bryson City.

The new service also speeds deliveries from Knoxville. Freight placed in the Knoxville warehouse by four o'clock in the afternoon now reaches Murphy the next day.

Changes also are being considered in the passenger service between Murphy and Asheville. An official of the passenger department told the Scout that a way is being sought to draining, clearing and cleaning up put passengers in Murphy earlier in the day.

According to this railway official a plan is under consideration under which trains between Murphy and Asheville would leave each terminal at night, placing the passenger in either city, early the next morning.

Schedules whereby trains would leave the two terminals in the afternoon, also are being considered.

"Under the present system" the official explained, "a passenger going either to Murphy or Asheville has most of the day taken up by travel, arriving too late to do much business until the next morning. This means a waste of time we are trying to eliminate. Just what changes will be made, however, have not yet been decided."

Murphy formerly had an incoming and outgoing train from and to Asheville daily, but the service was cut down because of lack of patronage
