Late News Bulletins

Adolf Hitler has taken direct command of the battle of Germany, it was revealed Wednesday as British armored forces turned the flank of the Siegfried line in Holland, entering Nijmegen in a swift drive that threatened momentarily to break across the Rhine on the high road to Berlin.

Red army forces were within sight of Riga Wednesday as three powerful armies totaling nearly one million men cracked German defenses along a 170 mile front to virtually close a trap on tens of thousands of Nazi troops in the Baltics.

American troops breached the Gothic line along a six-mile front North of Florence Wednesday and drove to within three miles of Fidenza, junction of two main highways leading northward through the Apennine Mountains.

Reports presented to the United Nations relief and rehabilitation administration conference in Montreal indicate the huge relief demands of Europe will keep factories in the United States, Britain and Canada busy for at least 12 months after the collapse of Germany.

He then went to Lowell Tech. Institute for further training at Boston, Mass. After completing his training S/Sgt. Mulkey returned to Anti-Aircraft school at Camp Davis, where he received his S/Sgt. rating. S/Sgt. Mulkey has received the good conduct and sharp shooting medals.

He is now on furlough in Andrews with his wife and parents before resuming his duties at Ft. Bliss, Texas.

With Tenth District Commissioner Percy B. Ferebee as host, members of the North Carolina State Highway and Public Works commission held their September meeting in this county last Thursday. Accompanying the commissioners and highway engineers here were Governor and Mrs. J. Melville Broughton and Mr. and Mrs. D. Hiden Ramsey of Asheville.

The business meeting of the commission was held Thursday morning at Terrace hotel. Andrews, headquarters for the two-day visit here. Only routine business was transacted, according to the members.

At noon the party came to Murphy, where the Town of Murphy was host at a picnic dinner, served by a committee headed by Mrs. J. H. McCall. Mayor W. M. Fain welcomed the guests.

Following the meal the visitors left by boat for Hiwassee Dam. Boats used included one from the coast guard at Hiwassee Dam, with Lt. Com. A. L. Meckling as

host; and boats belonging to Dr. W. A. Hoover and Walter Mauney. A. D. Rieger, head of the property management of the TVA, and other TVA officials were hosts on an inspection tour of Hiwassee Dam and the power house. Included in the tour also was an inspection of Apalachia dam and power house.

The party returned by way of Farmer and Ducktown, Tenn., through the copper basin.

On Thursday afternoon from three to five o'clock Mrs. Broughton and Mrs. Ramsey were honored at a tea given at Terrace hotel, details of which are given in another page of this paper.

Mr. Ferebee was host to the visitors at a dinner at the Terrace Thursday evening.

Leaving Andrews about 8:30 Friday morning, the group went to Pontana Dam, stopping en route to view Nantahala Gorge and Nantahala Power and Light company developments, and in Robbinsville where Graham county citizens showed the Governor and other members of the party the comparatively new courthouse. Other stops were made at Lake Cheoah and Lake Santeetlah.

The party was met at the entrance to the Pontana Dam area by a TVA patrol car and escorted to the administration building, which houses the general offices of the project. Here they were greeted by Fred Schlemmer, project manager, and other department heads, who conducted a tour of the project.

The trip included a tour of the construction area, a visit to the powerhouse, a stop at the observation platform, a walk across the high level trestle, and a visit to the quarry and the primary crushers.

The party were guests at a luncheon at the cafeteria, given by the recreation association, an organization of employees of the project. Mr. Schlemmer spoke briefly concerning the fine spirit of the employees and the speed with which the dam has been built. Stating that it was first believed it would require six years to complete the project, he announced that it will be finished within three years from the date it was started. Mr. Schlemmer presented Governor Broughton, who commended the officials and workmen on their accomplishments.

The following officials who assisted Mr. Schlemmer as hosts for the day were presented: G. E. Murphy, construction superintendent; Dr. Joe Gambil, head medical officer; Glen Reed, construction engineer; W. N. Rogers, personnel officer; Henry Sherrill, camp manager; and Raymond Couch, cafeteria manager.

Inspection of the hospital and guest houses was included in a tour of the village in the afternoon. Returning to the administration building Governor Broughton was asked to make a recording of his impressions of the project. He was presented by Mr. Ferebee. The message was later broadcast to workers at the dam, from the TVA's public address system studio.

In addition to the highway commissioners and division engineers, there were in the party: Mr. Ferebee, T. B. Ward, director of the state division of motor vehicles; Vance Baise, state highway engineer; G. Harsh, assistant TVA highway engineer; Governor and Mrs. Broughton, Mr. and Mrs. Ramsey, Mr. and Mrs. E. A. Wood, Miss Addie Mae Cooke, and Mrs. C. R. Tarkington.

Vincent Wilson Is Presumed To Be Dead; Was One Of Five Brothers In Service

Vincent Wilson, Seaman first class, U. S. navy, is presumed to have been lost on August 18, 1943, according to word received by his parents, Mr. and Mrs. I. N. Wilson of Marble, from the Secretary of the Navy, who wrote:

"You have previously been informed by the Bureau of Naval Personnel that your son, Vincent Wilson, Seaman first class, United States navy, was being carried on the records of the Navy Department in the status of missing. He was a member of the armed guard crew serving on board the SS J. H. Senior, when that vessel collided with a friendly ship in the North Atlantic area on August 18, 1943. Immediately several explosions occurred and both ships were engulfed with heavy fires. At the time of the collision the night was dark, there being a heavy fog, and the sea was rough.

"In view of the length of time that has elapsed without any indication that your son survived, and because of the strong presumption that he lost his life at the time of or shortly after the collision, I am reluctantly forced to the conclusion that he is deceased. In accordance with the provisions of Section 5 of Public Law 490, 77th Congress, as amended, his death is presumed to have occurred on 19th August, 1944, which is the day following the expiration of twelve months in the missing status.

"I extend to you my sincere sympathy in your great loss and hope you may find comfort in the knowledge that your son gave his life for his country, upholding the highest traditions of the Navy. The Navy shares in your bereavement, and feels the loss of his service."

Mr. and Mrs. Wilson have had five sons serving in this war.

Vincent entered the service in February 1942 and received his

basic training at Norfolk, Va. After serving on the Pacific Fleet, stationed at different ports in California, he was sent to New Zealand, Australia, India and China, where he spent several months. He is survived by his parents; two sisters, Mrs. G. M. Phillips of Asheville and Miss Millicent Wilson of Marble, and the four brothers named below.

Cpl. Johnny L. Wilson enlisted at the age of 18 in the spring of 1940. He received training at Fort Jackson, S. C., and Camp Forrest, Tenn., and was shipped overseas from a California port.

Sgt. Gerald J. Wilson entered service at the age of 15, in May, 1941. He took basic training at Fort Belvoir, Va., being sent from there to Fort Meade, Md., and from there to Camp Reynolds, thence to England. He is now a messenger from Scotland to Northern Ireland.

Woodrow U. Wilson, seaman first class, received his basic train-

ing at Bainbridge, Md. He was employed at a war plant in Philadelphia prior to entering service. He is now serving off the coast of Virginia.

Pvt. Hubert H. Wilson, at the age of 14, served eight months in the Marines, and was honorably discharged. He is now with the Army on maneuvers in the South.
