#### **Funeral Held** Saturday For **Glenn** Crowe

Funeral services for Glenn Crowe, 33, who was killed Thurs day morning when a gasoline drum exploded at his store at Unaka. were held Saturday afternoon at 2 o'clock at Unaka Baptist church. Mr. Crowe had been demonstrating a welding torch, which he placed on an empty gasoline drum. The drum exploded from the heat, and Mr. Crowe was struck on the side of his head by the top of the drum and died before reaching the hospital.


