

AN ORDINANCE PROVIDING FOR THE 30-DAY QUARAN-TINE OF ALL DOGS

WHEREAS, a number of dogs nave contracted rables within the

icinity of Murphy within the past few days, and it is probable that a number of dogs have been bitten by the dogs already mad and an epidemic of rabies is feared; and whereas, the city authorities are informed by the rabies inspector that a very large proportion of the dogs in the City of Murphy and surrounding vicinity have not been vaccinated, as is by law provided; and whereas, there are a large number of dogs roaming the streets of Murphy who apparently have no owners and, not being vaccinated, are a potential menace, as well as a nuisance to the

public at large; And whereas, the North Carolina State law, General Statutes 106-364 to 106-387, provide that oll dogs shall be vaccinated for rabies annually: Now, therefore, be it ordained

by the Mayor and the Board of Aldermen of the Town of Murphy: SECTION I. That all dogs of any sex or strain within the city limits of the Town of Murphy shall be confined by their owners upon their own premises for a period of 30 days, provided that during said leave the premises of the owner if on a leash and under the control of its owner or other responsible person, or if the dog be ade
