# Joshua Brooks gets state OK for liver funds



## The Brooks family

The board of trustees of the/state employees health insurance plan voted Wednesday to permit pay-ment of claims for liver transplants, paving the way for an ail-ing 8-month-old Laurinburg boy to get the costly operation.

After meeting for nearly five hours, the board voted 5-2 to amend the health plan to cover liver, bone marrow and cornea transplants. Previously, the coverage neither included nor excluded transplants.

The decision delighted Eddie R. and June M. Brooks of Laurin-burg, whose 8-month-old son Joshua needs a liver transplant to stay alive. Without it, doctors say, the boy could live no longer than six mo

insured under a health plan provided by the state. But before Wednesday's decision by the plan's board of trustees, state offi-cials were unsure whether their in-surance benefits could be used.

Although private donations of nearly \$60,000 have been raised toward the operation, estimates of the cost range from \$140,000 to more than \$200,000. The Minnesota hospital is one of three hospitals in the nation that perform the opera-

R. Brent Hackney, a Hunt spokesman, said the board's deci-sion was in line with the gover-nor's recommendation that the ba-

nor's recommendation that the ba-by's surgery be covered. "It comes as good news to us," said Hackney, who sat through most of Wednesday's discussion. "It didn't look good for a long time, but apparently they got it worked out." The boy's father, who also sat through all of the discussion, said he felt good about the decision. "We feel we've done all we can for Joshua," he said. "He's got a lot of chances, and the bottom line is that now he hast meets a liver." in that now he just needs a liver."

Elections for the four board seats is October 18, at 7 p.m., in the Pembroke State University gymnasium in Pem-broke, N.C. Each year, four positions on the 12-person Board of Directors come open for re-election for three-year terms. here are nine directors representing nine geographic districts in the four-county service area, and three directors elected at-large. The Board of Directors operate as the policy and procedure making body of the cooperative. The by-laws of LREMC allow nomi-


ations by submitted petitions over the gnatures of 15 or more members. Deadline for petitions was Friday, September 23, at 5 p.m. Nominations can
