Syrup of Ipecac is an agent which induces emesis (vomiting) when used appropriately. The ingestion of toxic substances, particularly by children, is a significant problem in terms of incidence rate and morbidity/ mortality. In many cases the prompt induction of vomiting following poison ingestion will greatly reduce the potential health hazards which can be associated with

such ingestions. Educational material and detailed instructions for proper usage of syrup of lpecac will accompany each bottle of


### Businessman Found

**BODY OF LUMBERTON MAN FOUND** 



"He died from a bullet wound to the lower part of the head," the sheriff said Monday afternoon.


