In Pembroke Township, Robeson County, North Carolina about one half mile southeast of Pembroke on the southeast side of N.C. Highway 711 and adjoining, bounded on the northwest and southwest by Dr. M.L. Brooks and on the east and southeast by James Clark and being described as follows:

Beginning at an existing iron stake in N.C. Highway 711, 10 feet southwest of center, James Clark's northeast corner (19-E at Page 329); runs thence as Clark's northwest line with Dr. M.L. Brooks south 42 degrees 45 minutes west 278.50 feet to an existing iron stake; thence as Clark's southeast line south 47 degrees 30 minutes east 205 feet to a point in the center of a canal; thence with said canal north 84 degrees 10 minutes 40 seconds east 97.67 feet to an iron rod in said canal; thence with said canal north 66 degrees 37 minutes 10 seconds east 223.49 feet to an iron spike in N.C. Highway 711 10.50 feet southwest of center; thence with N.C.
