## An Interview On... THE AMERICAN BACKACHE



With Dr. Harvey C. Schultz, Jr. DOCTOR OF CHIROPRACTIC

Recently a high school teacher gave a short quiz that tested the pupils' ability to match the specialist with a health problem. When asked where an individual would best seek treatment and care of a back problem, 75% of them said, "At the Chiropractor."
