

Homemaking Trends

Since 1919, KitchenAid mixers have provided reliable, outstanding performance, ease of use, and long life. The key to the mixer's efficiency is the Planetary mixing action which assures faster, more thorough blending of ingredients all the way to the edge of the bowl. As a result, different sized bowls for different tasks are not needed and continual bowl scraping is unnecessary.



According to home economists from KitchenAid, although all mixers are adjusted at the factory so that the flat beater just clears the bottom of the bowl (1/16"), sometimes during shipping this clearance may get out of adjustment. Here is a simple test to determine if your beater to bowl clearance is still at the correct level. Place a dime at the bottom of the mixer bowl and attach the bowl to the mixer. Attach the flat beater to the mixer and turn the mixer to Stir Speed. The beater should touch the dime every time it goes around the bowl. If the beater does not touch the dime, the clearance is too high.

The home economists advise that the clearance can be adjusted on the models K45SS

and KSM90 by tilting the head back and turning the screw located at the top of the stand, near the joint of the head (see page 8 in the recipe and instruction book). To adjust the clearance on a model K5SS, contact an Authorized Service Outlet.
