 Examples of duties: An employee in this position is trained to perform various tests in the treatment of raw water. Physical tests include turbidity, color, odor, taste and temperature. Chemical tests include PH, alkalinity, carbon dioxide, hardness, metal content, residual chlorine fluoride, and bacteriological and plate count. Additional duties include: daily checking of filters, chlorine machines, reading meters, gauges and dials, and performing routine preventive maintenance to all equipment. Work is characterized by the involvement in the Water Treatment Well division of the water treatment program. Higher level operators will provide supervision and training to the trainee. The Trainee will be trained to perform various tasks requiring considerable independent judgement and will be evaluated by the condition of treated raw water and the proficiency of performing assigned duties.

Qualifications: Graduation from high school or GED, supplemented by technical courses in water well and/or plant operations; or an equivalent combination of experiences and training.
