was Jesus a created being as some teach? Two proof texts often used by those who downplay Jesus' divinity are Rev. 3:14 and J Col. 1:15. First. the phrase "the beginning of the creation of god" the Greek word used for "beginning" is "ar-khay," it also means origin or principle. If we use the word origin instead of beginning notice how it could not longer be interpreted to mean that Jesus was the first created being, but rather all creation came into existence from His power.

For now, let's just say it is one of the two choices. Secondly, Col. 1:15 declares Jesus to be the firstborn of every creature. The logic used here is that because the term firstborn is used to describe Jesus. then He must be a created being, albeit the first created. If this logic is followed, the Col. 1:18 must mean that Jesus was the first to rise from the grace and Ephraim was also a first born, according to Jeremiah 31:9, See I Chronicles 26:10. Clearly these are nor the literal cases, but are illustrative of the position which each held in the sight of God.
