The writer of this passage of scripture recognizes the knowledge of the all knowing God. He realizes that he has examined him and knows his ups and downs. The writer acknowledges that the places he goes, and even when he sleeps God knows all about him. It would do all of God's children good to come to his knowledge. God even knows what we are gong to say before we say it. Whatever a person does or wherever he may go God knows it before hand. This might not sound good. an acquaintance knew everything about you because he might use it to bring harm to you. God. on the other hand, uses His knowledge of

us to make us better people
The infinite mind of man has trouble grasping how great God is in His knowledge of him. The writer here is appalled all things God knows about him: it is just beyond anything that our mind can comprehend

II. God Accompanies Us Psalm 139:7-12)

A Need for Reform of General Statues of State and Federal Wildlife Agency

There is a GREAT NEED for all people to understand the reverence. respect, and connection that Indian Traditionalists feel towards the Earth.

mankind, and animals The American Indian does not believe in the taking of a bird's life or fur-bearing animals simply to obtain its garment or parts. The taking of such has always been done in order to provide food for our people. We believe in and support regulations that protect endangered species, birds of prey, and yes especially our nation's symbol, the Eagle. We do not con-done the willful killing of these birds.

When we find a bird of prey (road kill) along the road side, traditionalists believe it is proper to extend its life through the taking and respectful use of its feathers and other parts Traditionalists also believe in reverencing a moment to reunite its body to the Earth, that its spirit may forever soar the skies with descendants that follow. This is a traditional custom of the American Indian and has been for thousands of years....long before the arrival of the white man. The current law forbids most Indians the right to possess the reverenced feathers and claws of the birds of prev and migratory birds.

The current law allows one to hunt the deer, turkey, and dove, and to possess its meat and eat thereof. But it is illegal to sell its antlers on a knife handle or to sell a bow quiver made from its hide. It is also illegal to use or sell the dove feather in a dream catcher. It is even illegal to possess or sell the feather of a turkey. eagle feather or any part of the eagle thereof unless he or she are members of a Federally recognized Tribe; and then the feather(s) are to be inventoried with the "Federal Fish And Wildlife Agency". This regulation has been in place for nearly 50 years and is in direct contradiction to the American Indian Religious Freedom Act, 42-USC 1996". And to top that, Federal Agents may audit your inventory of Eagle feather(s) (should you have any) to determine your compliance or non-compliance. The "Federal Fish And Wildlife Agency" isn't the only agency that needs re-form. The "North Carolina Wildlife's" Regulations are just as much out-dated and contradictory to the "American Indian Religious Freedom Act". In fact, many believe that both the current Federal and State Regulations discriminate against the American Indians, their freedom, and pursuant of happiness in the observance of their heritage. spiritual gatherings, and culture. The time is at hand for a change in both the State and Federal Wildlife Regulations. There is a great need for a

The need of reform to the "General Statutes" of the "State and Federal Wildlise Agency" will provide state recognized tribes. Native American Organizations, communities, and public officials an opportunity to interact with one another to achieve greater freedom for all our American

Indian citizenship.

The current "General Statutes" are well over half-a-century old! It is time for changes!

We as an indigenous People, and as the 7th largest State in Indian population should envision a collaborative effort that will provide freedom and opportunity in the God given right to possess, own, and use feathers and furs in our traditional celebrations, religious events, and other everyday life activities.

The accomplishment of a reform will not be an easy or short-termed task. A cooperative partnership must be initiated by Local, State, and Federal Agencies.

A statewide set or rules that revises and defines current regulations on the use of migratory birds, birds of prey, and fur-bearing animals is long past due. Such an act would enable the In-

dians of North Carolina, as well as. all other States the opportunity to legally wear any feather or any part thereof of a bird of prey, migratory birds, and/or fur-bearing animals without fear of incarceration due to the current and outdated State and ederal Regulations

The Statewide set of rules and Federal rules must not contradict one

This enactment would ease the current stringent regulations while casing discrimination and unfair regulations affecting the American Indian. A revised enactment would strengthen the traditional, spiritual values held by the American Indians.

and permit us a greater freedom. The organizational development of the enactment would consist of a staff of Native American Organizations, Tribal Bodies, State Agencies, Federal Agencies, and public input as a part of the cooperative process of developing and promulgating new regulations pertaining to feather, furs. and parts thereof.

In order to maximize the public's response, the State's applicable agencies should lead in developing and administering a survey that will lead in developing a new enactment. All Indian Communities and Organizations should also targeted in this

There is a great need to ease the current State and Federal Regulations as how they discriminate against the traditional values and religious beliefs of the American Indian.

There is a great need to simplify current Federal Regulations as pertaining to the taking, possession, and use of feathers, furs, and parts thereof

There is a great need to simply and case stringent regulations, i.e., salvage permits. documentation

forms, reports, etc. There is a great need to revise State and Federal Wildlife Regulations so as they are not contradictory to the "American Indian Religious Freedom Law 95-341" enacted by the 95th Congress on August 11.

1978 and revised in 1996. There is a great need for all American Indians and Indian Organizations to rally together, nationwide, to fix that which has been so wrong for so long. We as American Citizens have the right to celebrate our heritage and to preserve our traditional values and customs, after all, are we not the "First Americans"?

Your silence will be your acceptance to the status quo
