North Carolina Communities Granted \$9.4 Million To Recover From Hurricane Floyd

Washington - Senator John Edwards announced on Friday that Greenville and Rocky Mount will receive over \$9.4 million to repair public housing damaged by Hurricane Floyd.

"This is more progress toward providing help to North Carolinians devastated by Hurricane Floyd," said Senator Edwards. "The extent of the damage caused by Hurricane Floyd is truly overwhelming, and I'm glad these communities will have the financial support they need to recover."

Greenville will receive \$7,705,801

and Rocky Mount will receive \$1,772,200 from the U.S. Department of Housing and Urban Development under their Disaster and Emergency Capital Fund Program.

"Hurricane Floyd is the worst disaster North Carolina has ever seen," said Senator Edwards. "I am doing everything in my power to make sure that hard-working North Carolinians get all the help they need to recover fully from the damage that has been done to their homes, their businesses, and their communities."

In the Armed Forces

Air Force Master Sgt. Bobby L. Posey Jr. has been named senior non-commissioned officer of the quarter.

During the eight weeks of training, the trainee will receive instruction in drill and ceremonies, weapons, map reading, tactics, military courtesy, military justice, physical fitness, first aid, and Army history and traditions.

Whitaker is the daughter of Brenda K. Townsend of 505 N. Jackson St., Raeford, N.C., and sister of Vanissa K. Townsend of Forest Creek Road, Waldorf, Md.

In 1998, she graduated from Hoke County High School, Raeford.

Plans for Asbury Home for Native Americans Underway

Hearts are softened and stretched far and wide as individuals try desperately to minister to so many people who suffer physically, mentally, or economically.

Several ministers and other concerned persons attended a meeting Saturday, January 15 at Prospect United Methodist Church to discuss plans to construct a group home in the Robeson county area that would be targeted to serve Native Americans who suffer from significant cognitive impairment.

Dr. Virgil Daughtery, executive director of Southeastern United Methodist Agency for Rehabilitation (SEMAR), conducted the meeting as he proposed to the group the purpose of the home and what it required. Considerations of the project included: that hopes of land would be acquired through gifts and efforts of the local community in cooperation and coordination with Asbury Homes, SEMAR, and SEJANAM - South-

eastern Jurisdictional Agency for Native Americans, that different funding opportunities as community gifts and support, state grants, federal grants as well as private foundation gifts would be given to build and operate the home, and that the funds for operation of the group home would come through the local mental health agency and the home would be managed and administered by Asbury Homes.

Phillip Brown, chairman of the board of Asbury Homes, expressed his concerns of the home and how its mission strongly assisted disadvantaged people. "We want to develop ministries for the handicapped and also help individuals' spiritual and growth development. Expressing the love of Christ Jesus is our mission," stated Mr. Brown as he feels that these individuals need to be tied to the local community.

With everyone expressing a great interest in this endeavor, a task force was immediately formed with Gary

Locklear being selected as chairperson and Rev. Robert Ray being selected as vice-chairperson.

The task force invites everyone who shares an interest to please attend the next meeting scheduled February 13 at 2:30 P.M. at Pembroke First United Methodist Church.
