

McIntyre co-sponsors Bullet-proof Vests

Washington, D.C .-- U.S. Representative Mike McIntyre has become an original cosponsor of the Bulletproof Vest Partnership Grant Act of 2000. This legislation would reauthorize the highly successful grant program which McIntyre supported in 1998 to help law enforcement officers in the line of

Congressman McIntyre stated, We need to do all that we can to protect those who serve to protect us. The goal of this legislation is simple: to save the lives of police and corrections officers. The FBI estimates that the risk of fatality for an officer not wearing body armor is 14 times higher than for officers wearing vests. I encourage my colleagues in both the House and Senate to pass this legislation immediately so that we can provide a bulletproof vest for every state and local law enforcement officer who needs one.

The Bulletproof Vest Partnership Act of 2000 would provide \$50 million with up to 50% matching grants to state and local law enforcement agencies in order to purchase bulletproof vests and body armor. The legislation guarantees that all agencies serving smaller jurisdictions, which often have extremely limited budgets for vests, are provided with full 50-50 matching grants. In addition, the bill expands the current program to include body armor which meets the new stabproof standard which will prove vital to corrections officers and sheriffs departclose quarters.

1999, the grant program distributed enough awards to fully match funds for the purchase of 87,000 vests for 3.511 jurisdictions across the na-
