



NCAC Grassroots Grant **Deadline Nears**

The Carolina Civic Center will accept requests for 2002-2003 Grassroots grant funds through March 31, 2002. The Carolina Civic Center will serve as the local distributing agent for these funds. The Grassroots Art program is a partnership between the North Carolina Arts Council and communities, which allows for the decentralization of state funding decisions, provides a system of annual arts funding decisions, and provides a system of annual arts funding to every county in the state. North Carolina provides its major support of local arts projects through this program by allocating funds on a per-capita basis.

Grassroots grants are available to any non-profit tax-exempt organization in Robeson County offing cultural programming for the community. A committee consisting of local business and artistic leaders will review Grant requests. This committee will then present funding recommendations to the North Carolina for approval.

All requests must include the standard application form as well as an itemized budget for the project. The deadline for submitting requests for funding is March 31, 2002.
