Brother Doug

I would like to take the time to honor the memory of my late brother Douglas and my youngest

children. I thought that losing my father was hard but, it was nothing compared to losing my only known sibling I know that there are other children out there that belong to my father For he told me that when he was returning from Europe from WWII that he was paying child support for four children. He never went any further on that subject or I would find them only for a visit It was hard to lose my brother but. I will never hold the choice that he made against him I could see a change in him the day that he read my father's chart in the hospital that stated that the prognosis was death. Even the doctors did not have any hope for my father Several days before my father died Douglas had his first heart attack less than ten days after my father's funeral he had his second one

I remember the evening that he and the doctor called 1 was told by the doctor that he wanted to put that hose down my brother's mouth and take him back to ICU But, that my brother wanted to talk to me first. "Can I go Sis"" he took another breathe "will you be alright" He did not call his estranged wife or his children, he called his little sister who had fought for him and had always been there to help him fight his battles. Personally, I thought that he meant if he could go to ICU and I remembered him a promise that I would never let them put that tube down his throat. "Yes, you can go. I will be alight, you just fight until I get there. I am on my way, love you little brother" I said By the time that I ran and jumped in the shower the phone rang again. "I don't know how to tell you this but when you told Doug that he could go. When we hung up the phone he flatlined and we cannot bring him back. He died on total life support" the doctor stated I colapsed by the phone, looked at my iusband Clinton who was also dving of Lung Cancer "Doug's dead!" I cried "You got to be kidding, give me that phone" he said. You should have seen the look of shock on his face when he found out that I was right.

When I think about it now, I know that my brother is in a better place He had lost everything that meant anything to him. He lost his wife, he heard his children call another man "daddy." He had lost his father who was his best friend and I was not enough to keep him here His death certificate read that the major cause of death was depression Another cause was his weight. But, what shocked me was that both my father and brother had died of a embolism to the heart. Man could not have brought them back, only God could.
