# Rebekah Revels Crowned Miss North Carolina



Rebekah Revels, 23, has won the crown of Miss North Carolina. Miss Revels, a 2001 UNCP graduate, is from St. Pauls and teaches at Lumberton High School. She was Miss UNCP 1998 and is the former Junior Miss Lumbee, Miss Lumbee, Miss St. Pauls and currently Miss Favetteville

She is the second Lumbee to win the state title and the second in the past three years She is the third UNCP graduate to win the Miss North Carolina title.

Francie Adler '83 and Lorna McNeil '02 accomplished the feat before

"I am both extremely proud and happy for Rebekah," said Chancellor Allen C. Meadors. "She embodies the characteristics we cherish in our graduates- commitment, intelligence, poise, dedication and ambition. She will be a tremendous representative for Fayetteville, UNCP, the Lumbee Tribe, and the State of North Carolina.

Miss Revels will hold the title for one year and represent North Carolina in the Miss America Pageant in September in Atlantic City, NJ. She

wins a \$12,000 scholarship. "This is overwhelming and probably the most emotional experience I

have ever had," she told reporters following the contest. Miss Revels is classically trained in voice. She performs opera, dances

and plays the saxophone. Her community service project is Alzheimer's disease awareness.

Miss Revels won preliminary competitions for swimsuit and talent, said Dr. Diane Jones, vice chancellor for Student Affairs. Dr. Jones

attended every night of the competition. "Rebekah had the grace, beauty and stage presence that spelled

winner," Dr. Jones said. "She was radiant, enthusiastic and a crowd pleaser from the very first night of competition.

"I have known Rebekah for years. She is a great person and incredible role model for her people," said Kay Oxendine of Business Services and host of the Public Radio Program "Native Voices." "She always has a smile on her lips and a good word to say. She is very deserving of this title and definitely has a great opportunity in the Miss America pageant. She has made so many people proud just by being her. Her new titles are just bonuses!"

""She is a beautiful girl and comes from a fine family," said Susan Cummings of Sampson-Livermore Library, "She will represent the good Old North State W well."


Senior citizens and physically challenged persons now can continue to live at home and remain independent will help from the "Seniors in Motion" program of North Carolina.
