Sixty-Two Young Men Will Get Their Diplomas.

(Special to Daily News.) Raleigh, May 30.—A. & M. college commencement opened yesterday morning with the inaugural sermon by Rev. David W. Howard, D. D., of Norfolk, who delivered before an immense audience a sermon that is declared to have been probably the most striking sermon to graduates heard here this commencement season.

The college alumnae held an annual meeting today and the annual address to the alumni was by Prof. I. O. Schaub. Tonight there was the annual commencement address by Hon. Richmond Pearson Hobson. The diploma to the graduates and other graduating exercises will take place Tuesday morning at 11 o'clock.

DROPPED DEAD AFTER SPEAKING AT SUNDAY SCHOOL CONVENTION

(Special to Daily News.) Randleman, May 30.—Wilson Davis, an aged man of this place, dropped dead yesterday just after delivering an address at the Sunday school convention held in the auditorium. Mr. Davis, who has long been superintendent of St. John's Sunday school, had closed his address with the words "God bless you till we meet again," when he was seen to stagger to his seat. Skeletons Were Found.

(Special to Daily News.) New Bern, May 30.—The old structure of the St. Cyprian Protestant Episcopal church, which was built over 100 years ago, then being the place of worship for a Baptist congregation, but in later years purchased by the Episcopalians, has been torn down. In excavating for the foundation of the new church, which will be the finest negro Episcopal church in Virginia and North Carolina, six human skeletons were found that were supposed to have been buried over century ago. Their bones were exceedingly large and their teeth were apparently as firm as they were when the bodies of these pioneers were interred.

Death of Mrs. S. G. Culbreth.

Fayetteville, May 30.—Mrs. Sarah Gertrude Culbreth, wife of John H. Culbreth, prominent wholesale merchant of this city, died suddenly of apoplexy at her home yesterday afternoon in the 36th year of her age. Mrs. Culbreth was a most estimable Christian woman, highly esteemed by a wide circle of friends. She was a member of the First Presbyterian church of Fayetteville, and was prominent in the work of that organization. Her sudden death comes as a great shock to the community, and much sympathy is felt for the bereaved family. She is survived by her husband, two small children and a brother, Edward Smith, of Richmond, Va.
