Richmond, March 18, 1864. I. General Orders, No. 26, A. & I. G. O., March 1st, 1864, is herewith made a part of this circular...

III. Commandants will order the immediate enrollment and examination of all persons within the prescribed ages, with the exception of those in a department of the government...

V. Persons for Conscription Reports by the Commandant of Conscripts will be forwarded; also forms for the Reports of the Congressional District, and Local Enrolling Officers...

VII. EXEMPTIONS BY EXAMINING BOARDS. 1. Persons who shall be determined by the Board of Examiners to be exempt from performing active service in the field...

VIII. EXEMPTION OF SPECIFIED CLASSES AND INDIVIDUALS. 1. Applications for exemption under the 3d and 6th articles of the 10th section of the act aforesaid...
