The Permanent Constitution of the Confederate States of America.

We, the people of the Confederate States, each State cting in its sovereign and independent character, in order to form a permanent federal government, estabsh justice, insure domestic tranquility, and secure the lessings of liberty to ourselves and our posterity-inoking the favor and guidance of Almighty God-do in and establish this Constitution for the Confederate States of America.

### ARTICLE I .- Section 1.

All legislative powers herein delegated shall be vested in a Congress of the Confederate States, which shall consist of a Schate and House of Representatives

1. The House of Representatives shall be composed of members chosen every second year by the people of the several States; and the electors in each State shall be citizens of the Confederate States, and have the qualifications requisite for electors of the most numerous branch of the Sate Legislature; but no person of foreign birth not a citizen of the Confederate States shall be allowed to vote for any officers, civil or political, State or Federal

2. No person shall be a representative who shall not have attained the age of twenty-five years, and be a citizen of the Confederate States, and who shall not, when elected, be an inhabitant of that State in which

he shall be chosen. 3. Representatives and direct taxes shall be apportioned among the several States which may be included within this Confederacy according to their respective numiters, which shall be determined by adding to the whole number of free persons, including those bound to service for a term of years, and excluding Indians not taxed, three-fifths of all slaves. The actual enumeration shall be made within three years after the first meeting of the Congress of the Confederate States. and within every subsequent term of ten years, in such manner as they shall, by law, direct. Section 5. 1. Each Hou e shall be the judge of the elections, returns and qualifications of its own members, and a majority of each shall constitute a quorum to do business; but a smaller number may adjourn from day to lay, and may be authorized to compel the attendance of absent members, in such manner and under such penalties as each House may provide.

2. Each House may determine the rules of its proreedings, punish its members for disorderly behavior, nd, with the concurrence of two-thirds of the whole unber, expel a member.

3. Each House shall keep a journal of its proche sings, and from time to time publish the same, excepting such parts as may in their judgment require secresy, and the yeas and nays of the members of either House, on any question, shall, at the desire of twe-fifth of those present, be entered on the journal.

4. Neither House, during the session of Congress, shall, without the consent of the other, adjourn for more than three days, nor to any other place than that n which the two Houses shall be sitting. Section 6.

1. The Senators and Representatives shall receive a compensation for their services, to be ascertained by aw, and paid out of the treasury of the Confederate States. They shall, in all cases, except treason, felony and breached the peace be privileged from arrest during their attendance at the session of their respective Houses, and in going to and returning from the same; and for any speech or debate in either House they shall

not be questioned in any other place. 2. No Senator or Representative shall, during the time for which he was elected, be appointed to any civil office under the authority of the Confederate States which shall have been created, or the emoluments whereof shall have been increased during such time; and no person holding any office under the Confederate States shall be a member of either House duduring his continuance in office. But Congress may, by law, grant to the principal officer in each of the Executive Departments a scat upon the floor of either House, with the privilege of discussing any measures

President of the Confederate States; if he approve, he shall sign it; but if not, he shall return it with his objections to that House in which it shall have origipated, who shall enter the objections at large on their journal and proceed to reconsider it. If, after such reconsideration, two-thirds of that House shall agree to pass the bill, it shall be sent, together with the oojections, to the other House, by which it sha!! likewise be reconsidered, and if approved by two-thirds of that House it shall become a law. But in all such cases the votes of both Houses shall be determined by yeas and nays, and the names of the persons voting for and against the bill shall be entered on the journal of each House respectively. If any bill shall not be returned by the President within ten days (Sundays excepted) after it shall have been presented to him, the same shall be a law, in like manner as if he had signed it, unless the Congress, by their adjournment, prevent its return ; in which case it shall not be a law. The President may approve any appropriation and disapprove any other appropriation in the same bill. In such case, e shall, in signing the bill; designate the appropriations disapproved, and shall return a copy of such appropriations, with his objections, to the House in which the bill shall have originated; and the same proceedings shall then be had as in case of other bills disapproved by the President.

3. Every order, resolution or vote, to which the concurrence of both Houses may be necessary (except on a question of adjournment) shall be presented to the President of the Confederate States; and before the same shall take effect, shall be approved by him; or being disapproved by him, may be repassed by twothirds of both Houses according to the rules and limitations prescribed in case of a bill.

### Section 8.

The Congress shall have power-1. To lay and collect taxes, duties, imposts and exises for revenue necessary to pay t'e debts, provide for the common defence, and carry on the government of the Confederate States; but no bounties shall be granted from the Treasury, nor shall any duties or taxes on importations from foreign nations be laid to promoteor foster any branch of industry; and all duties, imposts and excises shall be uniform thoroughout the Confederate States:

1. The importation of negroes of the African race from any foreign country other than the slaveholding States, or Territories of the United States of America, is hereby forbidden; and Congress is required to pass such laws as shall effectually prevent the same.

2. Congress shall also have power to prohibit the introduction of slaves from any State not a member of, or Territory not belonging to, this Confederacy. 3. The privilege of the writ of habeas corpus shall not be suspended, unless when in cases of rebellion

invasion the public safety may require it. 4. No bill of attainer, or ex post facto law, or law denying or impairing the right of property in negro slaves shall be passed.

5. No capitation or other direct tax shall be laid unless in proportion to the census or enumeration hereinbefore directed to be taken.

6. No tax or duty shall be laid on articles exported from any State, except by a vote of two-thirds of 7. No preferences shall be given by any regulation

of commerce or revenue to the ports of one State over hose of another. 8. No money shall be drawn from the treasury, but

in consequence of appropriations made by law; and a regular statement and account of the receipts and expenditures of all public money shall be published from 9. Congress shall appropriate no money from the

treasury except by a vote of two-thirds of both houses, taken by yeas and nays, unless it be asked and estimated for by some one of the heads of department, and submitted to Congress by the President; or for the purpose of paying its own expenses and contingencies; or for the payment of claims against the Confederate States, the justice of which shall have been judicially declared by a tribunal for the investigation of claims against the government, which it is hereby made the duty of Congress to establish.

All bills appropriating money shall specify in federal currency the exact amount of each appropriation and the purposes for which it is made; and Congress shall grant no extra ompensation to any public contractor, officer, agent or servant, after such contract shall have been made or such service rendered 11. 1. No State shall enter into any treaty, alliance, or confederation; grant letters of marque and reprisal; coin money; make anything but gold and silver coin a tender in payment of debts; pass any bill of attainder, or ex post jucto law, or law impairing the obligation of contracts; or grant any title of nobility.

2. No State shall, without the consent of the Congress, lay any imposts or duties on imports and exports, except what may be absolutely necessary for executing its inspection laws; and the nett produce of all duties and imposts, laid by any State on imports or exports, shall be for the use of the treasury of the Confederate States; and all such laws shall be subject to the revision and elagrol of Congress.

3. No State shall, without the consent of Congress, lay any duty or termage, except on sea-going vessels, for the improvement of its rivers and harbors navigated by the said vessels; but such duties shall not conflict with any treaties of the Confederate States with foreign nations; and any surplus of revenue thus deinted shall after making such immrovement the recip troops or ships of war, in time of peace, enter into any agreement or compact with another State, or with a foreign power, or engage in war, unless actually invaded, or in such imminent danger as will not admit of delay. But when any river divides or flows through two or more States, they may enter into compacts with each other to improve the navigation thereof. ARTICLE II.-Section 1.

1. The executive power shall be vested in a Presilent of the Confederate States of America. He and the Vice President shall hold their offices' for the term of six years; but the President shall not be re-eligible. The President and Vice President shall be elected as

2. Each State shall appoint, in such manuer as the Legislature thereof may direct, a number of electors equal to the whole number of Senators and Representatives to which the State may be entitled in the Congress; but no Senator or representative, or person holding an office of trust or profit under the Confeder-

ate States, shall be appointed an elector. 3. The electors shall meet in their respective States and vote by ballot, for President and Vice President, one of whom, at least, shall not be an inhabitant of the same State with themselves; they shall name in their ballots the person voted for as President, and in distinct ballots the person voted for as Vice President, and they shall make distinct lists of all persons voted for as President, and of all persons voted for as Vice President, and of the number of votes for each, which list they shall sign and certify, and transmit, sealed, to the government of the Confederate States, directed to the President of the Senate; the President of th Senate shall, in the presence of the Senate and Hous of Representatives, open all the certificates, and th votes shall then be counted; the person having th greatest number of votes for President shall be th President, if such number be a majority of the whole number of electors appointed, and if no person have such majority, then, from the persons having the highest numbers, not exceeding three, on the list of those voted for as President, the House of Representatives shall choose immediately, by ballot, the President. But in choosing the President the votes shall be taken by States, the representation from each State having one vete; a quorum for this purpose shall consist of a member or members from two-thirds of the States, and a majority of all the States shall be necessary to a choice. The person having the greatest number of votes as Vice President shall be the Vice Presdent, if such number be a majority of the whole number of electors appointed; and if no person have a majority, then from the two highest numbers on the list the Senate shall choose the Vice President: a quorum for the purpose shall consist of two-thirds of the whole number of Senators, and a majority of the whole number shall be ne-

cessary to a choice. 5. But no person constitutionally ineligible to the office of President shall be eligible to that of Vice President of the Confederate States.

6. The Congress may determine the time of choosing the electors, and the day on which they shall give their votes, which day shall be the same throughout the Confederate States.

7. No person except a natural born citizen of the Confederate States, or a citizen thereof at the time of the adoption of this constitution, or a citizen thereof born in the United States prior to the 20th of December, 1860, shall be eligible to the office of President: neither shall any person be eligible to that office who shall not have attain d the age of thirty-five years. and been fourteen years a resident within the limits of the Confederate States, as may exist at the time of his

Section 2. . 1. The President shall be commander-in-chief the army and navy of the Confederate States, and the militia of the several States, when called into tl. actual service of the Confederate States; he may re quire the opinion, in writing, of the principal office? in each of the Executive Departments, upon any subject relating to the duties of their respective office and he shall have power to grant reprieves and par-dons for offences against the Confederate States, except in cases of impeachment.

2. He shall have the power, by and with the ad vice and consent of the Senate, to make treaties, provided two-thirds of the Senators present concur; and he shall nominate, and by and with the advice and in actual service, in time of war or public danger; consent of the Senate, shall appoint ambassadors, other public ministers and consuls, judges of the Supreme Court, and all other officers of the Confederate States, whose appointments are not herein otherwise provided for, and which shall be established by law; but the Congress may, by law, vest the appointment of such inferior officers, as they think proper, in the President alone, n the courts of law or in the heads of departments.

\*3. The principal officer in each of the executive departments, and all persons connected with the diplomatic service, may be removed from office at the pleasure of the President. All other civil officers of the Executive Department may be removed at any time by the President, or other appointing power, when their services are unnecessary, or for dishonesty, incapacity, inefficiency, misconduct, or neglect of duty : and when so removed, the removal shall be reported to the Senate, together with the reasons therefor.

4. The President shall have power to fill all vacancies that may happen during the recess of the Senate. by a jury shall be otherwise re-examined in any court by granting commissions which shall expire at the end of their next session; but no person rejected by the Senate shall be reappointed to the same office during their ensuing recess.

Section 3. 1. The President shall from time to time, give to 20. Every law or resolution having the force of law, the Congress information of the state of the Confederacy, and recommend to their consideration such measures as he shall judge necessary and expedient: he may, on extraordinary occasions, convene both houses, or either of them; and in case of disagreement between them, with respect to the time of adjournment, he may adjourn them to such time as he shall think proper; he shall receive Ambassadors and other public ministers; he shall take care that the laws be faithfully executed, and shall commission all the officers of the Confederate States.

Section 4. 1. The President, Vice President, and all civil officers of the Confederate States, shall be removed from office on impeachment for, and conviction of treason, bribery, or other high crimes and misdeanors

ARTICLE III. - Section 1. 1. The judicial power of the Confederate States shall be vested in one Superior Court, and in such inferior courts as the Congress may from time to time. ordain and establish. The judges, both of the Supreme and inferior courts, shall hold their offices duing good behavior, and shall, at stated times, receive for their services a compensation, which shall not be

1 The indicial power shall extend to all cases arising under this Constitution, the laws of the Confederate States, and treaties made or which shall be made under their authority; to all cases affecting ambassadors, other public ministers and consuls; to all cases of admiralty and maritime jurisdiction; to controversies to which the Confederate States shall be a party; to controversies between two or more States; between a State and citizens of another State where the State is plaintiff; between citizens claiming lands under grants of different States, and between a State or the citizens thereof and foreign States, citizens or subjects; but no State shall be sued by a citizen or subject of any foreign State.

2. In all cases affecting ambassadors, other public ninisters and consuls, and those in which a State shall be a party, the Supreme Court shall have original jurisdiction. In all the other cases before mentioned the Supreme Court shall have appellate jurisdiction; both as to law and tact, with such exceptions and under such regulations as the Congress shall make.

3. The trial of all crimes, except in cases of impeachment, shall be by jury, and such trial shall be held in the State where the said crimes shall have been committed; but when not committed within any State, the trial shall be at such place or places as the Congress may by law have directed. Section 3.

1. Treason against the Confederate States shall consist only in levying war against them, or in adhering to their enemies, giving them aid and comfort. No person shall be convicted of treason unless on the testimony of two witnesses to the same overt act, or on confession in open court.

2. The Congress shall have power to declare the punishment of treason, but no attainder of treason shall work corruption of blood, or forfeiture, except during the life of the person attained. ARTICLE IV. Section 1.

1. Full faith and credit shall be given in each State to the public acts, records and judicial proceedings of every other State. And the Congress may, . aug 19. by general laws, prescribe the manner in wich such acts, records and proceedings shall be proved and the effect thereof.

### Section 2.

T. The citizens of each State shall be entitled to all the privileges and immunities of citizens in the several States, and shall have the right of transit and soin said slaves shall not be thereby impaired.

2. A person charged in any State with treason, felony, or other crime against the laws of such State, who shall flee from justice, and be found in another State, shall, on demand of the executive autority of the State from which he fled, be delivered up to be removed to the State having jurisdiction of the crime.

3. No slave or other person held to service or labor in any State or Territory of the Confederate States, under the laws thereof, escaping or lawfully carried into another, shall in consequence of any law or regulation therein, be discharged from such service or labor, but shall be delivered up on claim of the party to whom such slaves belong, or to whom such service or labor may be due.

1. Other States may be admitted into this Confederacy by a vote of two-thirds of the whole House of Representatives and two-thirds of the Senate, the Senate voting by States; but no new State shall be formed or erected within the jurisdiction of any other State; nor any State be formed by the junction of two or more States, or parts of States, without the consent of the Legislatures of the States concerned, as well as of the Congress.

2. The Congress shall have power to dispose of and make all needful rules and regulations concerning the property of the Confederate States, including the ands thereof.

3. The Confederate States may acquire new territory, and Congress shall have power to legislate and provide governments for the inhabitants of all territory belonging to the Confederate States lying without the limits of the several States, and may permit them, at such times and 'n such manner as it may by law provide, to form the States to be admitted into the confederacy. In all such territory the institution of negro slavery as it now exists in the Confederate States shall be recognized and protected by Congress
