Beef or pork in good 32 gallon white oak barrels, hooped with twelve good hoops, the heads doweled, and 3-4 of an inch thick, and the staves half an inch thick, sufficiently tight to secure the pickle, and to contain 220 lb. of clean, well cured beef or pork. Flour to be put in good sufficient barrel, fit for exportation, with eight good hoops, and to contain 196 lb. of good merchantable flour; the length of the staves ought to be twenty-seven inches, and the diameter of the head seventeen inches. Butter to be put in good, tight firkins, that will hold pickle.
