TETHE Stockholders of this Bridge would inform the public that great alterations in the floors and o ther parts of it have been made, and are making so as to render it perfectly saf, even in the darkest nights, to cross it without lights, there being a timber on each side to keep the wheels of carriages in their propa place, and which will also keep the highest loads from catching against the timbers of braces of the Bridge. Reports having been circulated prejudicial to this Bridge, from interested and improper motives, it becomes necessary to state to the pubic, that such reports are without a. ny good foundation whatever, that ore than three years use and exposure to severe gales, freshes and, at iffetent times uncommon weights upon it, testily most conclusively. hat its stability and safety are equal o that of any wooden Bridge in the United States, and the very be st attention shall constantly be paid to keep it so. 
