### Indicted Roxboro Mobsters To Face Trial January 26th

### Dr. Mary McLeod Bethune, Alumna Of Famous College To Deliver Founders Address

Seventy-five years of continuous service to community and nation with approximately nineteen hundred graduates giving good account of themselves as teachers, social workers, business women and home makers in the record of Barber-Scotia Junior College: This is an enviable past and should be a telling prophecy for the future.

Dr. Mary McLeod Bethune, an outstanding leader in education and national affairs and incidentally an alumna of Scotia is to deliver the Founders Day Address.

Ten years ago Scotia was reorganized with an all Negro faculty. In the reorganization program evidence points to the fact that the best in the traditions in this institution has been linked with sound educational practices of the present. Finer Christian womanhood is no less an objective to-day than in the earlier days when pioneers in education for Negroes laid foundations better than they knew. Religion, dramatics, art, speech; health and vocational expectation are emphasized in terms of life rather than mere academic measures.

During the last ten years a large number of the graduates have pursued studies in other institutions with excellent records and high academic recognition, a number of them having been graduated with highest honors.

The objectives sought in molding the lives and the thinking of the students are simply and briefly stated, but the outcomes reveals a sincerity of purpose which makes these objectives vital forces in classroom and extra classroom activities.

#### Durham Merchant Passes After Short Illness

Durham, Jan. 21. — E. D. Green 47, well known business man of Durham died at his home here on Fayetteville Road, Wednesday morning at 2:25.

Although Mr. Green had been in declining health for several months he was not confined to his bed until a few days ago. His death came as a distinct surprise to his hundred of friends in Durham, and other cities throughout this and other states.

The deceased was born in Durham County, and had lived here all of his life. For a long number of years he operated a thriving grocery business here in what is known as Hayti section of the city. He moved his business to the southern section of the city near his home after his health began to fail him several years ago.

In 1913 Mr. Green was married to Miss Dora Williams of Chatham County. His wife and no children survive him and Miss Nettie Green of Durham. Mr. Green is also survived by brothers, Owen and Nettie Green of Durham, two sisters, Mrs. Daisy Burrough of Morrisville.

The funeral will be held Thursday at the home with Rev. William H. Fuller, pastor of Mt. Zion Baptist Church, in charge of the ceremony, in the absence of the pastor Rev. Miles Mark Fisher of White Rock Baptist Church who is out of the city. Interment will be held at Beechwood Cemetery on Fayetteville Road.

### President Spaulding Makes Encouraging Reports At Annual Meetings

In his annual message to the stockholders of the Mechanics and Farmers Bank held, January 9, President C. C. Spaulding gave a most interesting report of America's largest Negro bank and cited instances of continued progress and growth. The meeting this year was well attended by stockholders and its interesting to note that of the entire membership of the Board of Directors not one receives a single penny for his service as such.

The president stated in his report that the bank this year had declared a 3 per cent dividend on its common stock and that \$2,000 had been added to the permanent surplus of the institution.

Said Mr. Spaulding: "During 1941 the Management of your bank did everything within its power to see to it that your situation keep pace with the swift parade of national as well as local events. In this connection, we sold \$72,550.00 par value of U. S. Defense Bonds during the year and are of the opinion that in 1942 our

#### PRESIDENT



L. S. Cozart, president of Barber-Scotia Junior College under whose leadership the institution is playing an important role in the development of Christian Womanhood. President Cozart will preside over the 75th Anniversary Celebration of the school which will be held January 27.

In presenting his eighteenth report as President of North Carolina Mutual Life Insurance Company, C. C. Spaulding informed the policyholders assembled in annual meeting, that the year 1941 was the most outstanding in respect the company has experienced during the forty-three years it has served the public.

Thus the vast resources accumulated by the policyholders, and held in trust for them by the company, are not limited to safeguarding the family against accident or death, but have supported and made possible the safeguarding of investments and have promoted the desire for better living."

**Outstanding Service**  
With reference to the outstanding service rendered by the life insurance companies operated by Negroes in America, it was stated that: "According to the annual report made by the statistician of the National Negro Insurance Association, 30 reporting member companies operating in 28 states disbursed \$14,571,441.30 in 1940. This was equivalent to \$7,005.50 for each working hour during the year, or over \$56,000.00 for each working day. Employment was given to 9,773 members of the race on the field and in the respective home offices."

**Life Extension Service**  
While possibly outside the confines of strict life insurance procedure, for a number of years, North Carolina Mutual through its Medical Director and the Life Extension Department has rendered a service to its policyholders that has proved of inestimable value. During the year and average of 25 policyholders and employees visited the department for consultation and medical advice each day. In addition thereto, over 450,000 pieces of health literature were distributed to policyholders, schools and colleges throughout the country in an effort to spread the principles of sanitation and personal hygiene, as well as to aid

### Superior Court To Hear Case Against 10 Accused Of Attempted Lynching

Roxboro, Jan. 19. —(CP)— Ten white men, accused of storming the Person county jail in an attempt to lynch Cy Winstead, accused of raping a white woman are scheduled to be tried here during the week of January 26.

Solicitor William H. Murdock said Tuesday the rape case would probably be called January 26 or 27 and that the mob case will follow immediately with Judge R. Hunt Parker, regarded as one of the sternest disciples of strict law enforcement on the North Carolina bench, presiding.

Winstead, 22, was arrested August 15 and charged with rape but he denied the accusation. Early that evening after he had been placed in the Person county jail a mob formed about the court house, grew larger and larger to its ultimate strength of 600 and shouted "lynch him! lynch him!" Sheriff M. T. Clayton appealed
