

Present Head Denies Any Plans To Quit Position At Raleigh School

A dark and foreboding sha-dow hung heavily over Raleigh this week when rumors were persistent that Dr. Harold L. Trigg, former president of St. Augustine College, was being mentioned as principal of Ligon High School of this city.

The rumor gained momentum when it was learned that Dr. W. H. Watson, present principal of the school would leave the city at the close of school to do further study. In a telephone conversation with a representative of the Carolina Times Dr. the rumor but knew nothing of his decision to terminate his position as principal of the school He stated emphatically that he expected to return to his same

it did learn that it is the belief of many responsible persons in Raleigh that Dr. Trigg could have the principalship of Ligon High School if he desired it.

Dr. Trigg is well-known in educational circles in North Carolina where up until last January he was president of St. Augustine's College and a member of the State Board of Education. His resignation from St. Augustine's in the middle of the school term is reported to have been the result of a mis-

An action to gain admission of Edisto Beach State Park was hreatened here this week by a group of Charleston Negroes unless the all-white park is opened of members of their race. The demand of the Negroes follows a refusal of state officials to prodiscussion during the 195-53 pe-

Intention of the Negroes to bring action if the park is not opened to them was disclosed in opened to them was disclosed in a letter addressed to State For-estry Commission under whose auspices state parks operate in outh Carolina. The letter was south Carolina. The letter was signed by Attorney John H. Wrighten and stated that the "separte but equal" doctrine of racial accommodations was no longer applicable.

The letter said in part:
"This comes to inform you that the colored citizens of Charleston and Charleston Edisto State Park Beach this County are desirous of using year, as previous years they were prohibited from using the same because of segregation under the 'separate but equal' doctrine, that was birthsome 58 years ago."
