STUDY AID AT HOWARD WASHINGTON, D. C.

Howard University officials 25 assistantships and fellow will be available to gra students in chemistry duate during the 1956-57 school year. According to Dr. J. Leon Shereshefsky, professor and head of the Department of Chemistry at Howard, grants are available for teaching, re-search, and. graduate fellow ships, and graduate assistant-The value of the grants and requirements, listed by Dr

Shereshefsky, follow: 1) Teaching Fellowships, of \$1,800 per school year, require 15 hours a week of assisting in the teaching of undergraduate courses. These fellowships are limited 'to students who have had training equivalent to the Master's degree, and are studying toward the Doctor of Phiosophy degree.

2) Research Fellowships, up to \$2,000 per year, require de-voting 20 hours' a week to an assigned problem and the re maining time to graduate study

3) Graduate Assistantships, of \$550 and \$1,100 per school


