An ordained Methodist minister, the Reverend Mrs. Stewart shared pastoral duties of the Gersuch Methodist Church in the nation's capital.

She is a graduate of Illinois Wesleyan and has done advanced study at Boston University, Colgate-Rochester Divinity School and Union Theological Seminary.

## Course Case Is Delayed Again Trial In Trespass Of Six In Golf

The retrial on charges of trespass for six men who won a court order prohibiting the city from barring Negroes from its golf course was put off again here this week.

Attorneys for the six objected to proceeding with the case on the ground that they had not been officially notified to appear in court.

The delay was granted.

The case was set to be heard again here Monday.

Defendants in the trespass

action are Philip Cooke, Leon Wolfe, George Simkins, Jr., Joseph Sturdivant, Samuel Murray and Elijah Herring.

They were originally arrested for attempting to play golf on the Gillespie Park golf course last year. A federal court decision ruled that the course was on city-owned property and that Negroes could not be barred from its use.

The city later decided to sell the course, but a fire this Spring which razed the clubhouse, closed the course.

The columnist has had their say, too, about the Vice President and the prospects of his becoming chief executive. Robert Spivack (Watch on the Potomac) asks the question: "Has Nixon grown up?"

He admits he is not quite sure. But he adds, "Before (Iko resigns), I'd like to see a little more of the 'New Nixon.' In short, I'd like to know what's now?"

## Statesville Man Fails To Show Up At Court

STATESVILLE  
A young Negro who was covered with a friend carrying on a love affair in his car with two teen-age white girls by police who stopped the car to cite him for a traffic violation, failed to show up here Monday night to answer the charge.

Late Monday, police were searching for A. J. Smith, who was charged last month with driving without a license. Smith was called but failed to answer in traffic court here Monday night.

A bond of \$125 for his appearance was forfeited and a capias for his arrest was issued.

News of the interracial love situation in the automobile touched off tempers here, but leaders from both races went on the local radio and issued pleas for calmness. No serious disturbance was reported in the wake of the discovery, though several minor incidents, including the arrest of 14 Negroes on charge of disorderly conduct, were reported.

Twelve of the 14 were convicted last night and fined \$15 each.

Following the discovery of the interracial love situation, the two white girls and their mother were spirited out of the city by police.
