ing school with them for a year.  
● Negro children find attendance in white schools "strenuous but not incapacitating."  
● White children in desegregated Southern schools suffer no "medical or psychiatric damage" and no "breakdown in ability to work, study and get along with friends."  
● Children of both races continue their studies "without impairment."  
● From an academic viewpoint desegregation is easier in elementary grade schools.

The study found pressures on Negro children in desegregated schools varied "only in degree" from those which had always faced them in their daily lives. It added that while it was hard for a Negro child to enter an all-white school, the change offered "hopes and opportunities for work, for assertion of self, which contrast with other moments that may have seemed to them not only hard but also futile and less fulfilling."  
Dr. Coles attributed changed attitudes in some white children to "getting to know a particular Negro child" and "thinking about the problem because they were part of a desegregated school." He quoted a white Atlanta high school senior:

"I've really changed a lot of my ideas. You can't help but have respect for them, the way they've gone through the year so well. They're nice kids, that's what you find out after a while. They speak well and are more intelligent than a lot of my friends..."

The delegates adopting the program were among 180 civil rights leaders from 33 North Carolina cities and from 10 other states attending the three-day workshop.  
At the workshop, the same delegates expressed the hope that although several servicemen had been called down for taking part in the civil rights movement, GI's on leave and in civilian clothing may still be able to participate in demonstrations.

The telegram to McNamara said: "Request Goldboro be placed off limits to Seymour Johnson Air Base personnel and dependents."  
"Racial discrimination in this city prevents Negro military personnel from exercising full rights of American citizens."

The request follows McNamara's own decision that cities near military bases can be declared off-limits to service personnel if racial discrimination is severe.

Speaking on the issue, Attorney McKissick said, "Not only in North Carolina, but in other Southern states where there are military bases and major civil rights organizations, we are going to see to it that the promises of the federal government are fulfilled."

LEADERS OPPOSE HEADS  
If other action taken at the three-day workshop, leaders issued an official resolution in opposition to the statements made last week by two officials asking for demonstrations to stop and negotiations to take over.

The resolution said that the leaders "regret that such a statement came from two of North Carolina's foremost educators (Dr. Walter Rifeley of Elizabeth City State College and Dr. Joseph H. Taylor of North Carolina College at Durham) and hope that they re-evaluate — honestly—the present racial crises in America."

They resolved "that when negotiations with those practicing racial discrimination are unsuccessful, they will continue mass demonstrations and other types of nonviolent persuasions pertinent to racial discrimination and free all America's citizens."

They said that demonstrations are the results of failures of attempted negotiations and cannot cease until racial injustices are completely erased.

The leaders sent excerpts from the resolution to President Kennedy and Governor Terry Sanford.  
In other matters taken up at the workshop, which was held at St. Joseph's A.M.E. Church here, a consultant stressed the need for civil rights campaigns in the areas of education and employment.

Edward N. Wilson Jr., an instructor at North Carolina College here, said, "Just because the hotels and restaurants are open is no reason for us to become complacent in our fight for equality. The areas of employment and education should become a part of our main attacks."

The workshop was sponsored jointly by the four major civil rights organizations in the country: the NAACP, the CORE, the Southern Christian Leadership Conference, and the Student Nonviolent Coordinating Committee.

McKissick saluted the large representation attending the workshop as an indication that "the desire for emancipation through direct action and demonstrations has reached the stage where it will be translated into a reality."
