

NAACP Passes Half Million In Membership

NEW YORK - Signaling its leadership in epoch-making civil rights activities of 1963, the Na-tional Association for the Advancement of Colored People for the first time passed the half million mark in membership.

Executive Secretary Roy Wil-kins reported at the Association's annual meeting here, Jan. 6, a total of 515,396 members as of Dec. 24. This figure represents an additional .117,988 members over 1962, an increase of 29 per cent. Youth membership reached 55,

867, a 50 per cent increase over the 1962 total.
