HOLT PLACES THIRD IN STATEWIDE SCHOOL BEAUTIFICATION CONTEST

Holt Elementary School was named state third place winner in the North Carolina School Beautification Contest Monday in a special awards ceremony at the State Archives Building in Raleigh. The contest is sponsored by the State Department of Public Instruction.

Over 300 schools on all levels entered the beautification competition this year. As one of the three statewide winners in North Carolina, Holt will be entered in the national school beautification contest. Holt's improvement efforts were guided by the Holt P.T.A. Beautification Committee chaired by Mrs. Shirley Glasgow.

Among the more than fifty classroom, schoolwide and community projects were a general outdoor cleanup, the creation of an outdoor classroom and nature trail, planting a variety of trees, shrubs and flowers on school property, an anti-litter campaign and a recycling program.

"Student involvement has been one of our main goals," said Mrs. Glasgow. "It seemed that real 'hands-on' experiences would help children develop not only an appreciation for their school, but a sense of responsibility for it."
