Mrs. Peggy Johnson Tapp has been involved in the restaurant business since 1957, the year she started her first job at the Chicken Box concession stand. Almost 60 years later, Mrs. Tapp remains

committed to the business, having provided many years of leader-ship, hope, food service, community service, and love to the Dur-ham community. A Durham native, Mrs. Tapp was born in Durham's West End community to Albert and Mrs. Elizabeth Johnson. The oldest of 6 children (3 girls and 3 boys), Peggy attended Durham's Public Schools.
