

His confederates were crouch d on one pellet in their cell, with their heads under their blankets, from Fresh Florida Oranges and Canned Black which they were with difficulty induced to emerge. One of them was crying bitterly, and he, with another, stoutly swore that had no hand in the bad business. They

were cowed and subdued. Of course no blame can be attached to Mr. Orr for his action in the matter. He only did his duty, and this he did with a fidelity, courage and coolness which can but win the admiration of all. His praises are in all mouths, and deservedly so. Though a considerable gash was cut in his head by the bucket, he was not seriously injured, and is to be congratulated upon his fortunate escape from worse harm, if not death.
