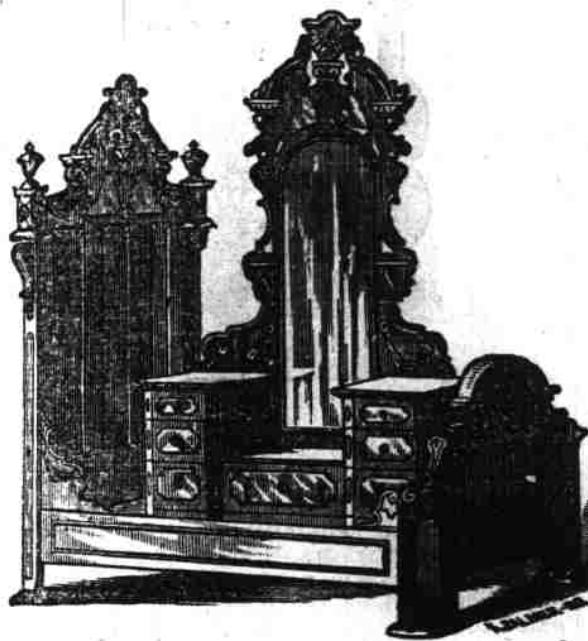

WASHINGTON.

Serious Measures in Regard to the Indian War—Civil Service Again.

Conkling Will Array Himself Against Hayes.

WASHINGTON, July 14.—The Cabinet yesterday considered the present Indian war, which they agreed to regard as equally serious with any of late years, and resolved to take every proper method to end forever the hostile demonstrations of the Indian tribes, to the extent of their power and appropriations. It is stated that the President will appoint Cowgill, a member of the Florida returning board, marshal of Dakota. The Dakotians here, remonstrate.

Henry C. Hall, consul-general at Havana, reports to the New Orleans board of health that there is no yellow fever outside of the military hospitals. He learns of no case among the shipping in the harbor.

The annual reports of the various executive departments will be presented to Congress when it meets on the 15th of October, instead of the first Monday of December, as has always been the custom. The bureau officers are ordered to have their reports ready by August 15th.

It is understood that hereafter no clerk will be allowed to leave his desk at election time unless the time he is absent be deducted from his annual vacation.

The Secretary of War has returned from Iowa. The Star says that a New York lawyer named Norton, at present a guest at the Ebbitt House, stated last night that he had the authority for the statement under the Senator's own signature, that Mr. Conkling would refuse to endorse the Southern policy of President Hayes.

Attorney General Devens has his Southern marshals under homeopathic treatment.

A dispatch received from Minister Washburne at Paris, brings the intelligence that he desires to be relieved from duty by August. Governor Noyes will therefore arrange to reach Paris before that date.

Minister Osborne has already sailed for his post in Chili, with important instructions in regard to certain questions in controversy.

Col. A. B. Wood, chief of the Consular Bureau, will relieve Van Buren, consul-general to Japan.

It is stated this afternoon that the President has tendered the Brazilian mission to W. A. Henderson, of Pittsburgh, the present United States marshal of the Western district of Pennsylvania, and a warm friend of Hayes' family.

Gen Howard Gives an Account of a Battle.

SAN FRANCISCO, July 14.—A press dispatch from Portland says the following official dispatch has just been received from Gen Howard: "By making a forward and forced march, I struck an enemy at 1 p. m., yesterday, about three hundred strong, in a deep canon near the mouth of the Cottonwood, and near the south fork of Clear Water. I opened fire at once with howitzers, and succeeded in starting the Indians from their position. Passing around transverse the canon for a mile and a half, I began the battle in good earnest, and, dismounting, formed in the ravines and behind rock barricades, well prepared. For seven hours every charge we made, gained on them. Still at night our position was not a very good one, as the army lay beyond my communications, and I was short of rations. This morning by a determined effort we regained our spring of water from some sharpshooters. This afternoon I gave orders to the case of Capt Perry commanding the cavalry, and Capt Miles' battalion of infantry. I drew out Capt Miller's battalion of artillery acting as infantry. Just as we were ready to recommence the offensive work, Capt Jackson and the pack train appeared in sight beyond the Indians' position. Miller pushed out in a skirmish order, met the train and escorted it successfully. They had hardly formed the junction with us, when the artillery battalion, already beyond the enemy's flank, made a rapid movement, taking Gatling guns and howitzers along. The Indians made a desperate effort to flank Miller, but failed, and then gave way. Everything was then pushed in pursuit. We shelled them rapidly from high bluffs as they escaped from the left of the river, and followed them, escaping in every direction, as far as the river, and are now across and going into camp.

7:30 P. M.—The loss of the Indians appeared to be thirteen killed and quite a large number wounded. We have Capt Bancroft and Lieut Williams, and eleven enlisted men killed, and twenty-nine wounded. The camps were abandoned in great haste, leaving much plunder. The Indians fought as well as any troops I ever saw, and so did out, not one man falling in his duty. I now believe that I am in fine condition, just as soon as Green appears from Boise, to make thorough work with these Indians. They are making for the Snake country, and I for concentration at Mount Idaho. The troops have never done harder or more rapid campaigning, or better fighting than these."

It is expected that by the 20th instant, the gap near Smith Island, heretofore left open for the accommodation of shipping, will be entirely closed at low water. The whole bar and river improvement is progressing satisfactorily; vessels drawing thirteen and a half to fourteen feet, navigate safely from Wilmington to the mouth of the river, and can cross the bar drawing sixteen feet.

LONDON, July 14.—The Times' Bucharest correspondent says that it is officially reported that Rastchuk is blockaded by the Russians.

The Czar has arrived at Fratesch, a station on the Bucharest and Guirgevo Railroad, where, according to some accounts, he is to take up his residence. The advance guard of another Russian corps has arrived at Ploresti.

It is reported that a camp for 80,000 men is prepared at Ploresti. A battle is expected at Ezki Dju-mandja, where the Turks are concentrated in great force.

The Times' correspondent at Cettinje telegraphs: "Several accounts agree that the destination of Suleiman Pasha's army is Adrianople."

The Daily Telegraph's Pera correspondent sends the following, dated Friday evening: "I have just heard on good authority that the Russians have been attacked simultaneously by Osman Pasha at Piana, and by Ahmed Eyoub Pasha at Monastir. The fighting lasted all Thursday and Friday. The Turks are getting the advantage."

The Daily News' Bucharest correspondent reports Friday night as follows: "Rumors are afloat here that serious, but as yet indecisive fighting is going on in the neighborhood of Biela and Arest."

The New Simnitza dispatch, dated July 10th, records another serious break-down on the bridge. A storm caused some iron pontoons to fill and sink. There is one small gap and another of about one hundred yards. The repairs will occupy at least a day.

A special from Guirgevo to the Times says: "From a close inspection of various batteries at Siabosia, and from observations of the Turkish positions facing them, it is perfectly explicable that the damage, both to Rastchuk and Siabosia, may have been caused in the course of an engagement without either Turks or Russians having designedly attempted to destroy the dwellings, consulates, &c."

The Times' Vienna correspondent circumstantially denies the latest reports of the Austrian military preparations facing them, and also that Baron Calice's visit to England has any political significance.
