WASHINGTON.

PROCEEDINGS OF CONGRESS.

Kellogg and Packard Buzzing Around Hayes—The New Orleans Mint—Stephens' Pacific Railroad Bill to be Recommended—The Coming Silver Dollar.

The sub-committee of the Senate Pacific Railroad committee will report in favor of Dorsey's bill as modified by Mr. Stephens.

SENATE—A large number of petitions were presented during the morning hour, among them many remonstrating against the passage of the bill to transfer the control of the life saving service from the Treasury to the Navy Department, and others remonstrating against the passage of any bill imposing a tax on incomes.

The rest of the day was consumed in a general debate on the diplomatic bill. Cox, of New York, endeavored to offer a resolution inviting the President to recognize the Diaz government in Mexico.

Mr. Saylor, of Ohio, reported from the committee on Ways and Means a joint resolution, which was referred to the committee of the Whole, extending the time for the withdrawal of distilled spirits from bonded warehouses to three years, and providing that the tax shall be levied at the rates required at the time of withdrawal.

Secretary Sherman was before the committee on Coinage, Weights and Measures, this morning, and gave his views about the proposed measure for issuing certificates of deposits of silver bullion.

Dr. Linderman, the Director of Mints, at the request of the committee, gave information concerning the facilities for coining the new silver dollar, and said that to double the present capacity would require three additional mints, or two in addition to that at New Orleans, at which five or six millions a month could be coined.

WASHINGTON, March 11.—Representative Turner, of Kentucky, has introduced a bill looking to the taxation of United States bonds equally with other property, for State purposes.

House—Elam, of Louisiana, introduced a resolution of the Louisiana Legislature, asking Congress to grant a charter to the Beretaria Ship Canal Company.

A resolution appointing Gen Sherman regent of the Smithsonian Institute, vice Babcock, passed.

A bill providing for a commission of five to consider alcoholic traffic, with an amendment by Mr Conkling that one member of the commission shall be engaged in the traffic, passed; yeas 21, nays 19.

Blaine called up his resolution regarding the fishery treaty, which gives Great Britain five million, and awarded the award at great length.

The resolution which calls for certain correspondence was agreed to.

He is deservedly popular, and is the only one who can re-organize the Liberal party, which has been sunk into discredit through the conduct of Signors Nicotora, Depretis and Crispi, but he is not administrator and will take no portfolio, only accepting the presidency of the council."

TERRIBLE TORNADO.

It Sweeps Through Atlanta, Tears Down a Church While It is Filled With People—Great Destruction of Property and Probably Several Lives Lost.

NEW YORK, March 10.—A special from Atlanta Ga, says that that city experienced today the severest wind storm or rainless tornado ever known there.

The storm burst suddenly about 11 o'clock a m, when all the churches were filled with worshippers, and lasted, without rain, with steady and tremendous force for two hours.

The Episcopal church, like the others, was filled at the hour for the commencement of divine service, and no thought of danger was entertained by the congregation, but during the early part of the service the wind suddenly rose and shook the whole building to its foundation.

Several other churches in the city were seriously injured—their walls shaken and the roofs partly stripped. The City Hall was entirely unroofed, and the car sheds and railroad depot unsettled.
