He said that certain Republicans apologized for supporting Blaine by saying that he was no worse man than Garfield, and the Governor admitted it. We candidly believe that Gov. BENNETT NOMINATED. AT THE LUMBERTON CONVENTION.

C., July 30.—Pursuant to the call of the district executive committee of the Democratic party for the sixth congressional district, of North Carolina, a large convention of delegates assembled here today to nominate a candidate of the Democratic party for Congress.

MR. HENDRICKS NOTIFIED. GROVER CLEVELAND.

The Committee Proceed to Saratoga and Perform the Duty Assigned Them. SARATOGA, N. Y., July 30.—The portion of the committee appointed by the recent Democratic National Convention for the purpose of notifying the Presidential candidates of their nomination arrived in town last night, and the balance came this morning. Mr. Hendricks is at the Grand Union Hotel.

The committee held a private consultation at Saratoga, and appointed a committee consisting of Messrs. Vilas, of Wisconsin, Waller, of Connecticut, Hooker, of Mississippi, and Stockton, of New Jersey, and a confeder with Mr. Hendricks and ascertain which would be the most agreeable hour to make the formal notification. The committee returned and stated that Mr. Hendricks would be ready at 2 o'clock, and that the ceremonies would take place in the large parlor of the hotel at that hour.

Mr. Waller, of the committee, introduced a resolution extending thanks to Hon. W. F. Vilas, chairman, and Nicholas M. Prinos, secretary of the committee, for the dignified and intelligent manner in which they had performed their respective duties.

Long before the hour arrived for the ceremony to take place the beautiful parlor of the hotel was filled with elegantly dressed ladies and gentlemen seated in a circle around the space reserved for the committee. At 2:10 o'clock amid loud applause from the assembled guests, the committee marched in and stood in a circle, followed immediately after by Mr. Hendricks, who took his position in the center of the group.

Upon his arrival Chairman Vilas delivered the following address: Gov. Thomas A. Hendricks, of Indiana, this evening we are gathered here in the constitutional Democracy of the Union had at Chicago, within this month of July, constituted this committee now before you by a selection from each of the several States and Territories of our country, and commissioned it as the official voice of the party to declare to you in fitting terms and with appropriate ceremony, not only its testimony of its respect for your abilities and character, but in pledge of its consideration for the interests of the Nation; that you have been nominated by the party to the people to be their Vice-President of the United States for the ensuing term of that exalted trust; that honorable duty which has been laid upon you, and which you have undertaken with pride and pleasing in this manner to discharge.
