#### STRANGLED ON A ROPE.

A Young Negro, Who Took His S; gross Employer's Life, Pays the Pen- Nonrolg BIOYAU

CINCINNATI, July 15.—The execu-tion here this morning of Joseph Palmer, colored, is the last that can take place in this county under the present law, which designates the Ohio penitentiary as the place for all future executions.

future executions. Paimer's crime was the murder of Wm. H. Kirk, in his stable, on the afternoon of December 24, 1881, and the object of the crime was robbery. William Berner and Paimer, both of whom had been employed by Kirk, planned and executed the murder. They were almost immediately ar-rested, and both confessed, each charging the other with dealing the fatal blow. It was the verdict in the Berner case of manslaughter that was the chief inciting cause of the riot in which the court house was burned in March, 1884. Berner is now in the Ohio penitentiary, serv-
