WASHINGTON, Nov. 20.-Varicus opinions are expressed as to what the Senate will do in the matter of con firmations. Several Republican Sevators have discredited the reports that there was to be wholesale or considerable objection to the Presi dent's appointments. It is said by Democrats that the Senators of the Democratic Administration, and can not therefore oppose factiously such cognizes as fitting and proper Undobt edly, however, there is a strong partisian feeling among the Republicans which may be sufficient to override all considerations of private or public policy. Nevertheless, the opinion that the President holds the rains and knows how to handle them, prevails where his character, and abilities are rated at their true mark.
