OLGA NETHERSOLE COMING.

Distinguished English Actress to Appear at Local Academy October 22—Another Ecological Play. Charlotte theatregoers will be interested to learn that Olga Nethersole, the distinguished English actress, will make her initial appearance in Charlotte this fall, Friday night, October 22. Miss Nethersole is one of the best-known actresses on the stage today and her coming to Charlotte will be one of the events of the theatrical season. As to the play she will appear in, she gave out the following interview prior to her departure for London a few days ago: "The enormous amount of interest manifested by my presentation of 'The Writing on the Wall' has encouraged me to offer next season another play by an American author, dealing with another vital social question that has heretofore escaped the dramatist's pen, one that is as bold in exposition and treatment as the crusade on tenement reform expounded in 'The Writing on the Wall,' and one that I hope will receive the approval of the public and the endorsement of the press.

"The immediate steps taken by several corporations and individuals to remedy some of the evils exposed by my play leads me to believe that the truths told have been driven home, and a move forward has been made in the emancipation of the tenement slaves.

"For many years I have exposed to the glare of the footlights, the social corruption of the individual, aiming thereby to disclose the pitfalls in the social structure, and placing the danger sign-posts thereon. Now I have advanced from the individual to the community and corporation, laboring to unveil certain sociological conditions that have been influenced by an unfavorable environment, the rectifying of which would surely and speedily redeem a certain percentage of weary souls, whose existence is stifled by unsanitary surroundings or dwarfed by social conditions over which they are helpless."

PASSED WORTHLESS CHECKS.

Recorder Smith Determined to Put a Stop to the Passing of Worthless Checks—A. G. Mentz Given Four Months. A. G. Mentz, the white man who was indicted in recorder's court yesterday morning for having passed a worthless check upon Dr. C. G. McManaway, was adjudged guilty and sentenced to the county workhouse for a period of four months. Dr. McManaway, the only witness introduced, testified that Mentz gave him two checks for \$20 which he received and sent to the bank for payment. The bank turned them down saying that Mentz had no funds on deposit. Dr. McManaway then wrote to Mentz, who was in Hickory, asking what he intended to do about it. He responded that he would be in Charlotte in a few days and settle the matter. Sure enough in a few days he saw Dr. McManaway and gave him another check for \$20, taking up in turn the two checks which had been returned. The check was also worthless as events proved, when while time Dr. McManaway has been trying to locate his man. Through his counsel, Mr. H. Williams, Mentz appealed to Superior Court, his appeal bond being fixed at \$500.

BRIDGE READY TO-DAY.

Efforts Being Made to Get Morehead Street Bridge Ready by This Afternoon. Interrupted traffic across the East Morehead street bridge is expected to-day, a large force of men having been engaged day and night since Wednesday working nightily to get everything in readiness for this afternoon's baseball crowd. Some little delay was experienced by reason of the dispute between the street car and railway authorities as to certain arrangements of the supports but everything has been adjusted. It will be recalled that President E. D. Latta of the A. C., made the proposition to repair the bridge at his own cost and then let the matter be adjusted either by agreement or in the courts as to the manner in which the settlement of expenses should be reached.

The bridge was pronounced unsafe for street car traffic but sound for vehicles and pedestrians. The A. C. had the greatest interest at stake and hence was very anxious to get the bridge repaired as quickly as possible. If nothing unforeseen develops to-day, the bridge will be ready for street car traffic this afternoon.

COLORED TEACHERS ADJOURN.

War on Tuberculosis Was Declared by the National Association—Officers For the Ensuing Year Elected. Asheville, June 25.—War on tuberculosis among negroes was declared to-day, when the National Association of Teachers in colored schools authorized the appointment of a committee to work up an interest in the prevention of tuberculosis in the several States, and to arrange for the formation of a national anti-tubercular association.

Dr. C. P. Wertenbaker, of the public health and marine hospital, Washington, D. C., delivered an address on "How to Prevent Tuberculosis." The association adjourned to-night with a strong address to the country, which took under consideration various phases of negro education, principal among which were the matter of bettering the rural schools, the special training of teachers, the increasing mortality of the race, and the need of corrective measures for the good of the negro boys.
