## **Hybrid Corn Studies** To Be Conducted

If you are one of the farmers who have been amazed with the outstanding results others have obtain. ed through the use of hybrid corn and there are still questions in your minds as to whether you could get the same results, then, here is your opportunity.

During Farm and Home Week, which will be held on State College Campus, August 25-29. a demonstration will be conducted to answer many of the questions pertaining to hybrid corn production in the state, and at the same time explain some of the main points in the breding of the crop.

Interested farmers attending the annual event will go to McCullers Test farm near Raleigh and as a part of the eight timely farm demmonstrations that are to be conducted on the test farm, the breeding process or development of new varieties of hybrid co;n for North Carolina will be explained by Dr. P. H. Harvey, research professor, in charge of com breeding at State College. Other demonstrations which will

be conducted during the tour are: corn and sweet potato driets, peanut. breeding, strawberry production, tobacco, cultivation practices, and sweet potato harvesting methods. A tou to the livestock farms of the college will furnish some of the latest practices being carried out in


