Raleigh, Dec. 29.—A little be-fore noon to-day one of the most beloved men in Raleigh, James H. Alford, almost seventy years old, was shot down and latally injured in his printing establishment by R. D. Bynum, a man of 35 years, one of his partners in the job print-ing business Alford died to-night. The other partner of the firm of Alford, Bynum & Christophers, namely Charles D. Christophers, was present and witnessed the shooting. The front door of the establishment is closed and the terrible affair occurred in the printing room, which is separated from the front office by a door.
